On behalf of our client, Harvey E. Yates Company, application is hereby made for administrative approval of an unorthodox location, pursuant to Rule 104-F, to permit re-entry and attempted recompletion of the Tenneco, Hondo-Federal No. 1 Well located 660 feet from the South line and 660 feet from the East line of Section 6, Township 17 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.


The Tenneco, Hondo-Federal No. 1 Well was drilled as an oil well to the Abo formation at a total depth of 7804 feet at an orthodox location for said well and plugged and abandoned on March 14, 1964. Harvey E. Yates Company proposes to re-enter the well, deepen the same to the Pennsylvanian formation and dedicate the S/2 of said Section 6 to the well.




