AMENDED APPLICATION

Dear Mr. Porter:

This letter constitutes an application for authorization to dually complete an oil - gas well and for approval of a non-standard gas proration unit.

1. Resler & Sheldon operates a well located 1980' from the south and 660' from the west lines of Section 20-T23S-R37E, Lea County, New Mexico.
2. The well above described is known as the Steeler #1. It was completed at a depth of 3668' as an oil well producing from the lower Queen sands and is prorated as being in the Langlie-Mattix oil field.
3. It is proposed to perforate the section between 3000' and 3100', to fracture the formation, and to produce gas through the casing-tubing annulus. The dual completion would be accomplished by setting a Halliburton type CL production packer at approximately 3120'.
4. The section from 3000' to 3100' is part of the Yates formation and being located in the NW $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 20-T23S-R37E will be in the Jalmat gas pool.
5. The acreage dedicated to the gas well will be the SW $\frac{1}{4}$  of Section 20-T23S-R37E. It is herewith requested that this non-standard gas proration unit be approved.
6. A plat of the area showing the location, acreage dedicated, and the offset properties is attached hereto.

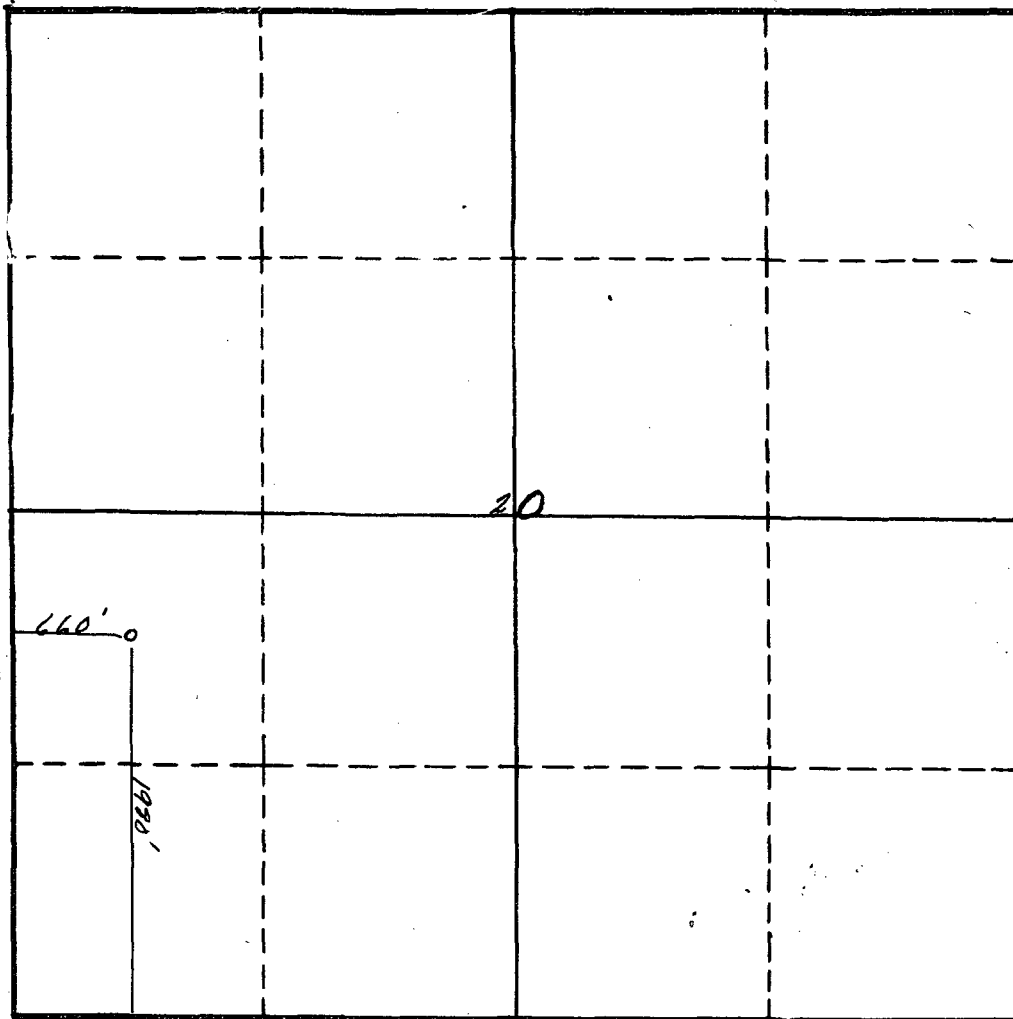
