Gentlemen:

Cities Service Company respectfully requests administrative approval as provided in N.M.O.C.C. Rule 104F for an unorthodox location for the Little Box Canyon Unit No. 4, Eddy County, New Mexico, because of topographical conditions.

The original proposed location for the well was 1980 feet from the East and 1980 feet from the ~~South~~ Lines of Section 12, 21S-21E with the dedicated proration unit to be the N/2 Section 12. Upon staking the location, it was determined a sheer ravine existed fifty-seven feet (57') west which was 150 feet deep. By moving the location to the east 330 feet, an acceptable drill site is available; therefore, we respectfully request administrative approval of an unorthodox location 1650 feet from East Line and 1980 feet from North Line, Section 12, 21S-21E, Eddy County, New Mexico, for the Little Box Canyon Unit No. 4. The proration unit will remain the same (N/2 Section 12).

Attached is a plat showing offset ownership and the location of the ravine in relation to the proposed well site.

The offset operator is being furnished a copy of this request.




Please advise us as soon as possible whether this was sent certified or registered to El Paso Natural Gas Company.
