Dear Mr. Ramey:

The above referenced well was originally drilled by Atlantic in 1964 and was plugged and abandoned at a TD of 11,654' by Schlumberger measurements.

It was re-entered by W. A. Moncrief, Jr. on 4-11-77 and deepened to 13,804' for tests of the lower Seaman and Morrow.

The well was completed as a Seaman producer in the South Kemnitz Cisco pool through perfs 11,522-11,696' on 5-31-77.

The Seaman zone depleted and the well has been plugged back for recompletion from the Kemnitz zone as an extension to the Kemnitz Lower Wolfcamp Field.

The location of this well is a non-standard location for the Kemnitz Lower Wolfcamp Field.

We are requesting that you grant us an allowable for this non-standard location since it was a re-entry of an old hole and since it was originally drilled as a wildcat and was later deepened as a wildcat.

I am forwarding a copy of this letter and plat to the Oil Conservation Commission office in Hobbs, along with copies of the revised Form C-102, Form C-103 and C-104.

I am also sending a copy of this letter and plat to Mr. Ken Reynolds of Western Oil Producers, Inc., in Roswell. They control section 28. Moncrief owns the remaining offset acreage.
