Blanco Mesaverde

As operator of the Northeast Blanco Unit, we are requesting administrative approval for a non-standard well location to be completed in the Mesaverde Formation.

We intend to drill the Northeast Blanco Unit Well No. 10A, an infill well, located 250' E/NL - 1060' E/WL. D-16-30N-7W, Rio Arriba County, New Mexico. The West half of Section 16 consisting of 320.00 acres, is dedicated to this well.

A segment of Frances Creek, a branch of the Navajo Lake, occupies a large portion of the NW/4 of Section 16. Due to the lake and adjacent bluffs, there is not a suitable well site available in the NW/4 of Section 16 on which a standard location can be built.

All offset acreage, both direct and diagonal, is within the Northeast Blanco Unit operated by Blackwood & Nichols Co., Ltd., except the E/2 of Section 16 operated by W. P. Carr. The distance from the requested location to the nearest lease line of a lease operated by W. P. Carr is 1580'. The total depth of our proposed Well No. 10A will be no greater than five degrees from the surface measurements. W. P. Carr was notified by registered mail on April 24, 1978, of Blackwood & Nichols Co., Ltd.'s request for authority to build this non-standard location.

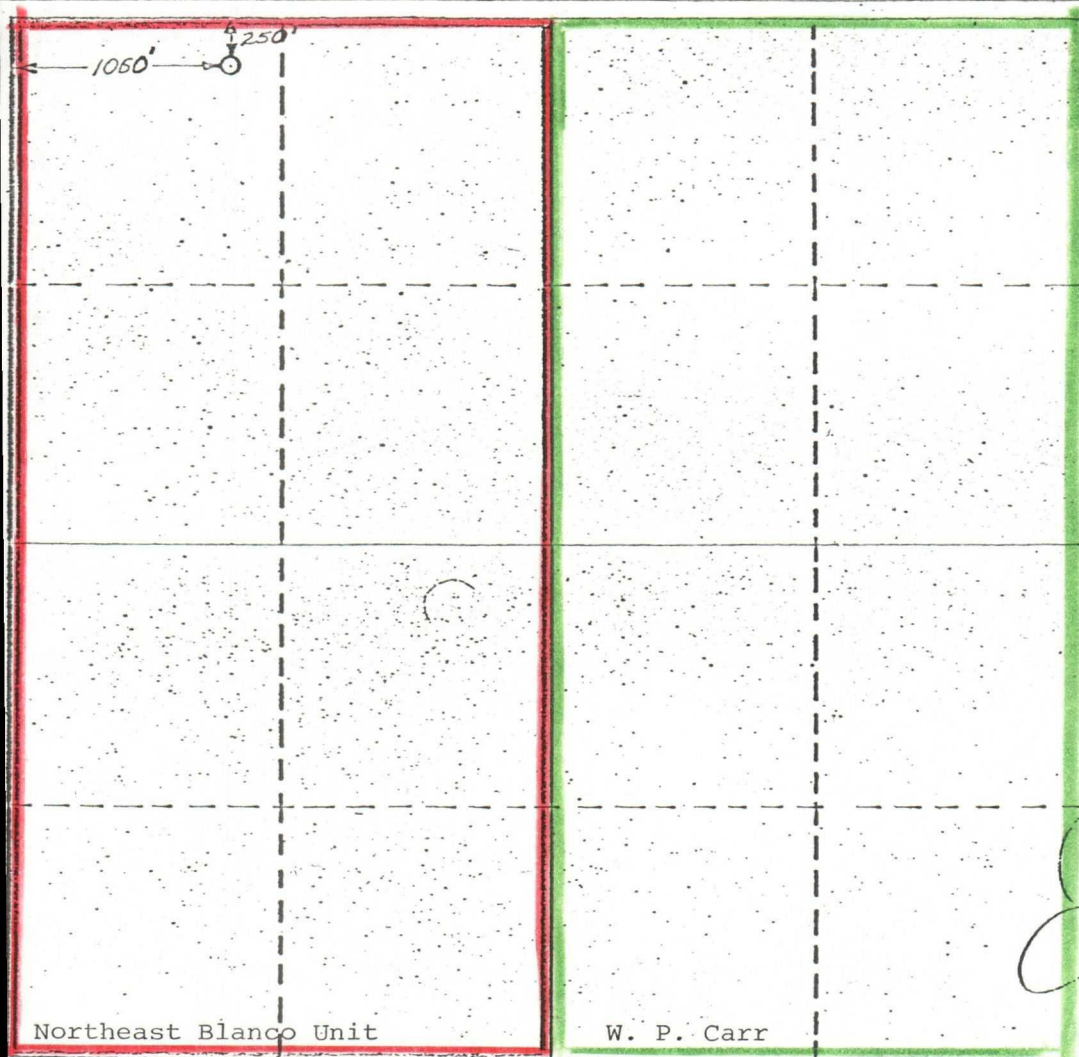

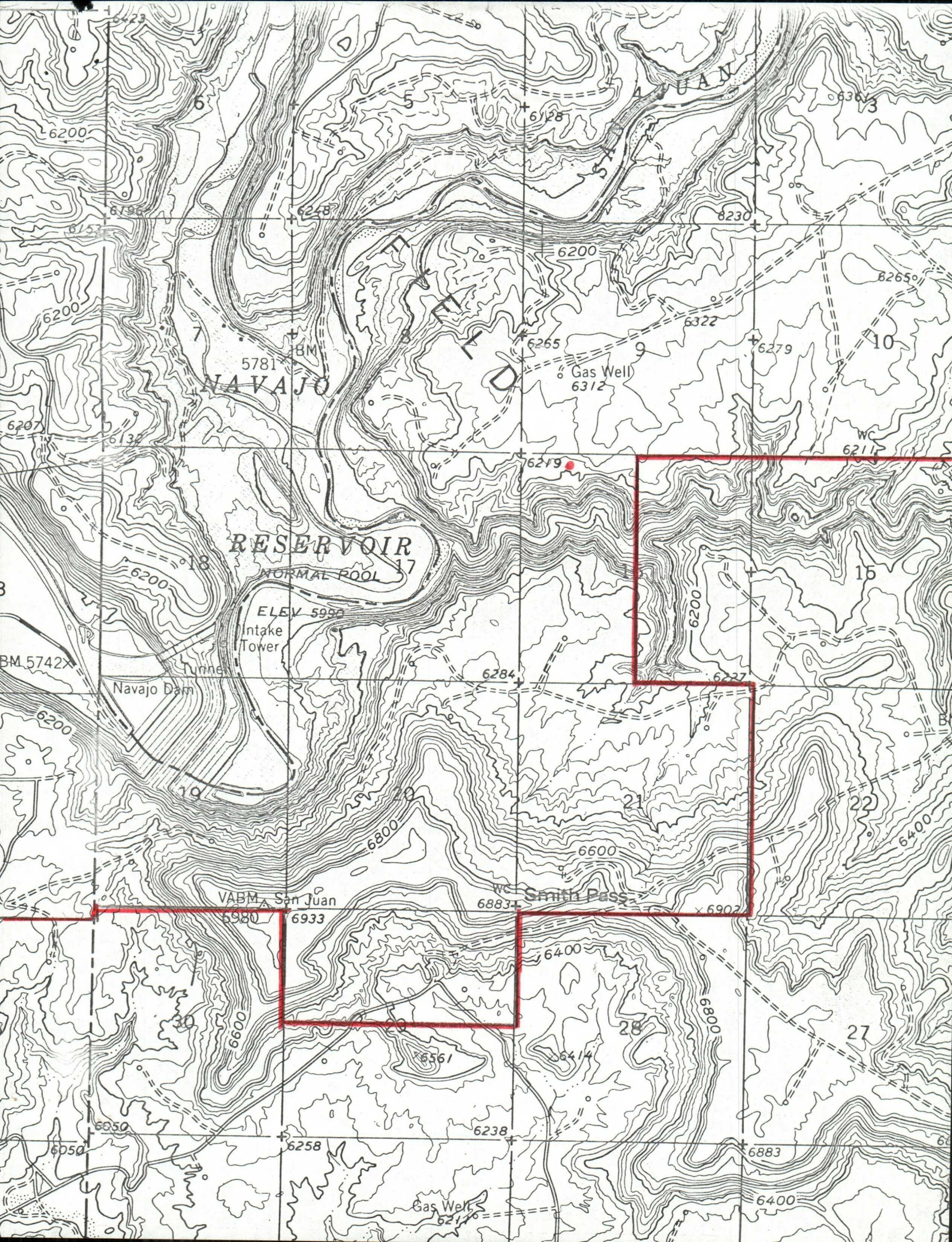
