The above-named company is hereby authorized to surface commingle oil, gas and water production from the North Burton Flat-Wolfcamp Gas Pool originating from all or part of the following-described Federal leases located in Eddy County, New Mexico:

Within the commingled area, the following-described wells are authorized for surface commingling:

The subject Federal leases, along with other Federal leases and additional acreage, are currently communitized to form a 2,560-acre area comprising all of Sections 14, 15, 22 and 23, Township 20 South, Range 28 East, NMPM.

Due to the diversity of ownership, oil, gas and water production from each of the above-described wells shall be separated and separately metered at each wellsite. Gas production shall be commingled at the compressor station and sold through Enterprises' gas sales meter located at the wellsite of the Government "AA" Well No. 1. Oil and water production shall be commingled after measurement and transported and sold at the North Burton Flat Central Tank Battery located at the wellsite of the Government "AA" Com Well No. 2.

NOTE: This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations. It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Artesia district office of the Division prior to implementation of commingling operations.
