RE: Request for administrative approval to drill Southeast Maljamar Grayburg-San Andres Unit wells Tract #4, Wells #9 & #10.

Gentlemen:

Cities Service Company, as operator of the Southeast Maljamar Grayburg-San Andres Unit, a secondary project, respectfully requests administrative approval to drill the following oil wells:

Tract #4, well #9, located 2,615' from the North line & 25' from the West line of Section 29, T-17S, 33E, Lea County, New Mexico.

Tract #4, well #10, located 2,615' from the North line, & 1,420' from the West line of Section 29, T-17S, 33E, Lea County, New Mexico.

Total depth of these wells is estimated at 4,350'. The proposed casing program for both wells is as follows:

The proposed perforations are estimated to be between 4,100' & 4,250'.

Tract #4, well #2, presently is producing in Unit E, the 40 acres to be assigned to Tract #4, well #9. Tract #4, well #2 will be converted to a water injection well and will not be produced as

an oil producer when Tract #4, well #9 is completed.

As shown on the attached plat Cities Service Company is the offset operator of these wells since these wells are located well within the boundaries of the Southeast Maljamar Grayburg-San Andres Unit.


