Gentlemen:

Reference is made to your application for a non-standard location for your W. A. Ramsay (NCT-A) Well No. 13 located 660 feet from the North line and 1980 feet from the East line of Section 35, Township 21 South, Range ~~36~~ East, NMPM, Eumont Gas Pool, Lea County, New Mexico. 37

Approval is also given to simultaneously dedicate your W. A. Ramsay (NCT-A) Well No. 7 located 660 feet from the South line and 1980 feet from the West line of Section 35, the above-described W. A. Ramsay (NCT-A) Well No. 13, and your W. A. Ramsay (NCT-A) Well No. 20 located 1980 feet from the North line and 660 feet from the West line of Section 35 to a standard proration unit. Further, you are hereby permitted to produce the allowable from any of the wells on the proration unit in any proportion.

By authority granted me under the provisions of Rule 3 of Order No. R-1670, the above-described unorthodox location is hereby approved.


