



Reference is made to Gulf's application dated November 13, 1978, requesting administrative approval for an amendment to Administrative Order NSL-990, for a standard proration unit in the Eumont gas pool, Section 35-T21S-R36E, Lea County, New Mexico, to be dedicated simultaneously to our W. A. Ramsay (NCT-A) Wells No. 3, 7, 13 and 20.

As requested by the Energy and Minerals Department, Oil Conservation Division, the following facts are submitted in support of our application. W. A. Ramsay (NCT-A) No. 3 was originally completed in the Arrowhead pool on July 24, 1938. Gulf has recently abandoned the Arrowhead pool and recompleted the well to a new horizon, the Eumont gas pool; therefore, Well No. 3 qualifies for administrative approval because it is a recompletion of an old well to a new pool.
