Gulf requests your administrative approval for an amendment to Administrative Order NSL-990, for a standard proration unit in the Eumont Gas Pool. The unit consists of all of Section 35-T21S-R36E, Lea County, New Mexico, and is to be dedicated simultaneously to our W. A. Ramsay (NCT-A) #3 located 660' FSL & 1980' FEL; W. A. Ramsay (NCT-A) #7 located 660' FSL & 1980' FWL; W. A. Ramsay (NCT-A) #12, located 660' FSL & FWL; W. A. Ramsay (NCT-A) #13, located 660' FNL & 1980' FEL; and W. A. Ramsay (NCT-A) #20, located 1980' FNL & 660' FWL.

In support of this application the following facts are submitted:

- (1) Order NSL-990, Amendment No. 2, authorized the simultaneous dedication of the 640-acre standard unit to Wells No. 3, 7, 13 and 20.
- (2) W. A. Ramsay (NCT-A) No. 12 was reclassified from an oil well in the Eumont Pool to a gas well in the Eumont Pool on September 1, 1979 and is presently closed in.
- (3) There are no other wells producing from the Eumont Gas Pool in this unit.
- (4) The attached plat shows the 640-acre unit and the locations of the five wells involved.
- (5) All offset operators have been furnished a copy of this application.

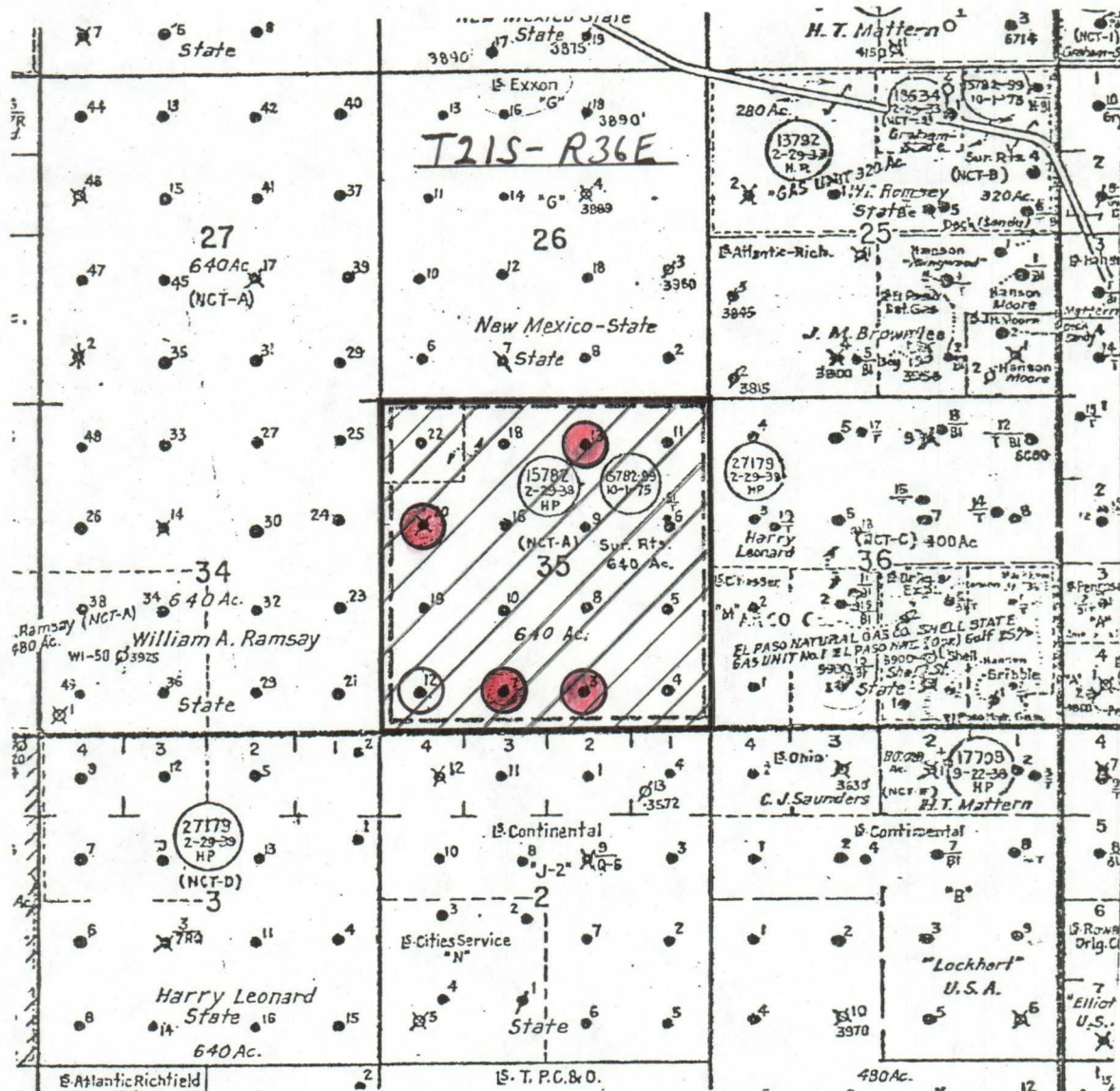
