Dear Mr. Stamets:

On October 31, 1979, a request (Case 6708) was made to the New Mexico Oil Conservation Division for our Custer State No. 1 for (1) an infield finding (2) and 80-acre non-standard Jalmat proration unit consisting of the SW/4 NE/4 and SE/4 NW/4 Section 36, T-24-S, R-36-E and (3) a non-standard location of 2310 FNL and 1650 FEL Section 36. Subsequent approval was recently received from the NMOCD in this matter.

Upon attempting to construct the required drilling pad for the subject well, it was determined that the well could not be drilled at the approved location of 2310 FNL and 1650 FEL Section 36 due to an El Paso Natural Gas Company gas pipeline crossing that point. Therefore, for the above mentioned topographic reason, the subject well was moved from the originally approved location to a more orthodox location consisting of 2310 FNL & 1800 FEL Section 36.

As a result of the required drill site change, we now respectfully request that the NMOCD approve a revised Jalmat non-standard location for the subject well consisting of 2310 FNL and 1800 FEL Section 36. A copy of this request has also been issued to all offsetting operators owning Jalmat (Gas) rights. The following is a list of all such operators owning Jalmat (Gas) rights.
