


Amoco Production Company hereby requests administrative approval for an unorthodox well location for the Armenta Gas Com C Well #1-E well in the Blanco Mesaverde Pool. Amoco has recently recompleted this well from the Basin Dakota to the Blanco Mesaverde. The spacing unit for this well is the N/2 Section 27. This well was originally approved at an unorthodox location in the Basin Dakota under Order NSL-1114. Similar approval is requested for the recompleted well in order to produce from the Blanco Mesaverde.

A copy of this application will be submitted to the offset operators by certified mail with a request that they furnish your Santa Fe office with a Waiver of Objection, and return one copy to this office. Attached are plats showing the location of the well, offset operators, and all wells drilled in the area.
