Describe Cause of Problem and Remedial Action Taken.\*

A Construction company ditching a new Right of Way hit a 6" natural gas pipeline with a ditching machine. The line was immediately shut down and isolated and the ditch line was blocked off within 50 ft. of the damaged line. A vacuum truck was dispatched to the site and approximately 60 bbls of crude oil was recovered from the ditch line. All of the impacted soil was excavated and placed on plastic the same day. Samples were collected from the bottom of the ditch to assure all of the impacted soil was brought to the surface.

Describe Area Affected and Cleanup Action Taken. The impacted area was contained to the ditch line measuring approximately 50 ft. long by 4 ft. wide. All of the impacted soil was removed from the ditch line and placed on plastic pending remediation or transfer to SUGS landfarm. The final remediation will follow the NMOCD guidelines for the remediation of leaks and spills.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
