Amoco Production Company hereby requests administrative approval for an unorthodox location in the Blanco Mesaverde Pool. Amoco has recently recomplected the existing Dakota producer, Fields 3 well, to the Blanco Mesaverde. The Dakota completion has been plugged back with a CIBP and Cement cap. The existing Mesaverde well in this quarter section (Fields A #4) was plugged and abandoned in March 1993 due to downhole mechanical problems.

The Fields 3 well was drilled in 1980 at an approved unorthodox location 1270' FNL and 1270' FEL of Section 28, T32N-R11W as a Dakota producer. Administrative Order NSL-1196 approved the location due to topographic conditions in this area. Since the well does not conform to the Blanco Mesaverde location requirements, an approval of unorthodox location is required.

All offsetting operators will receive a copy of this application by certified mail with a request that they furnish your Santa Fe office with a waiver of objection and return one copy to Amoco.

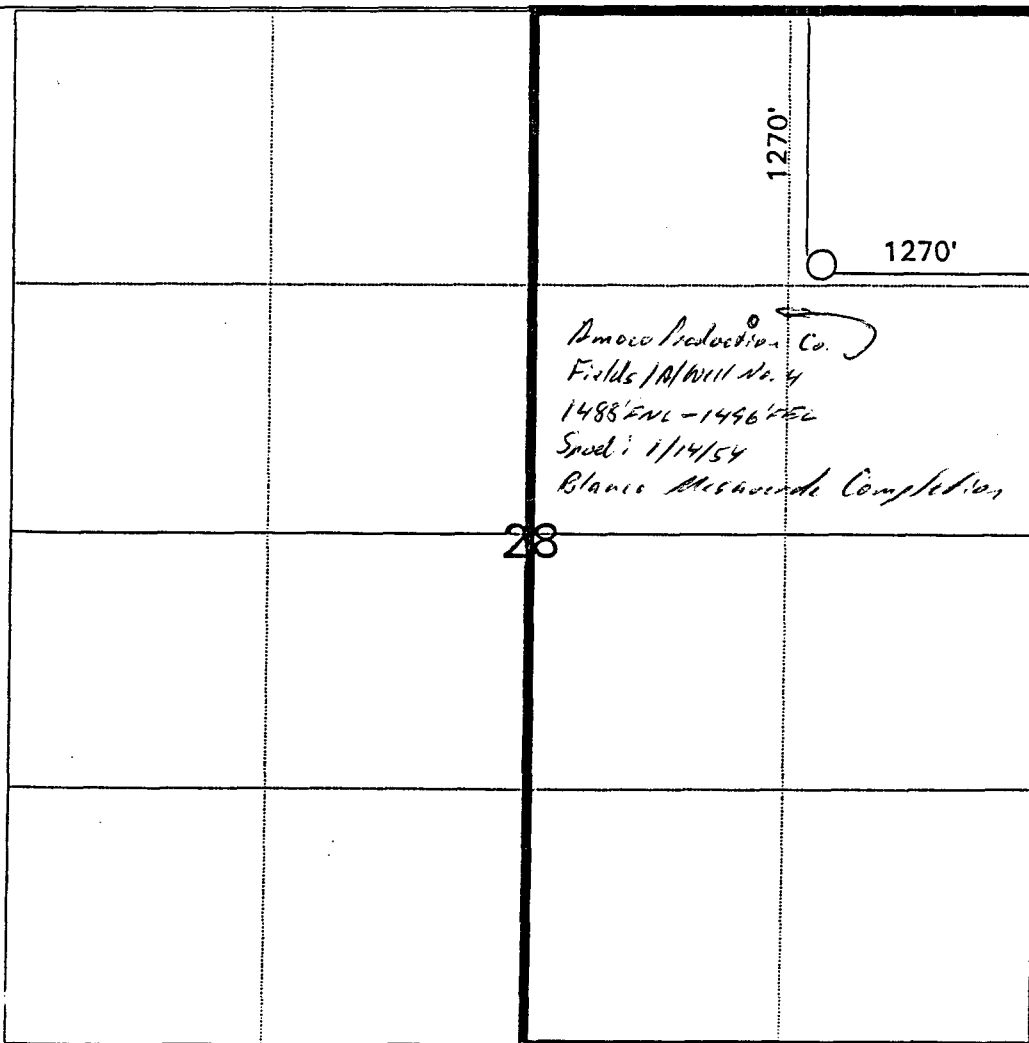
