Gentleman:

Holly Energy Inc. seeks administrative approval of an unorthodox Oil Well location under the provisions of paragraph F of Rule 104 of Oil Conservation Department Rules & Regulations dated January 1, 1976 based upon topographical conditions.

The Standard location in Lease No. LC 057634 falls in Highway U.S. 82. We propose to move location 90' to the North because of Highway U.S. 82 and power lines that are running 30' to the North and parallel with Highway.

The Non-Standard Location requested is 2400' FSL & 1600' FEL Section 20 T-17S R-30E. The proposed Well is the San Andres formation at a proposed depth of 3500 feet.

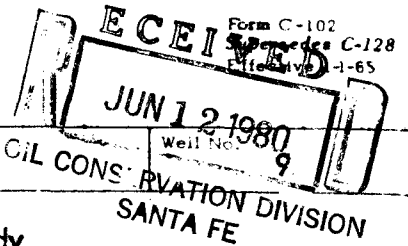
