Dear Ms. Carter:

Reference is made to the following: (i) your application dated April 6, 2001; and (ii) the records of the New Mexico Oil Conservation Division ("Division") in Santa Fe: all concerning Mack Energy Corporation's ("Mack Energy") request for an unorthodox infill oil well location within an existing standard 40-acre oil spacing and proration unit comprising the NW/4 SE/4 (Unit J) of Section 20, Township 17 South, Range 30 East, NMPM, Loco Hills-Paddock Pool (96718), Eddy County, New Mexico.

This 40-acre unit is currently dedicated to the following described Mack Energy operated wells:

- (i) McIntyre "A" Federal Well No. 3 (API No. 30-015-04221), located at an unorthodox oil well location (approved by Division Administrative Order NSL-3787, dated April 16, 1997) 2365 feet from the South line and 2310 feet from the East line of Section 20; and
- (ii) McIntyre "A" Well No. 9 (API No. 30-015-23407), located at an unorthodox oil well location [approved by Division Administrative Order NSL-1214-A (SD), dated August 19, 1998] 2400 feet from the South line and 1600 feet from the East line of Section 20.

This application has been duly filed under the provisions of Division Rule 104.F, revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999.

By the authority granted me under the provisions of Division Rule 104.F (2), the following described well to be drilled at an unorthodox infill oil well location within the subject unit is hereby approved:



Reference is made to the following: (i) your application dated April 6, 2001; and (ii) the records of the New Mexico Oil Conservation Division ("Division") in Santa Fe: all concerning Mack Energy Corporation's ("Mack Energy") request for an unorthodox infill oil well location within an existing standard 40-acre oil spacing and proration unit comprising the NW/4 SE/4 (Unit J) of Section 20, Township 17 South, Range 30 East, NMPM, Loco Hills-Paddock Pool (96718), Eddy County, New Mexico.

This 40-acre unit is currently dedicated to the following described Mack Energy operated wells:

- (i) McIntyre "A" Federal Well No. 3 (API No. 30-015-04221), located at an unorthodox oil well location (approved by Division Administrative Order NSL-3787, dated April 16, 1997) 2365 feet from the South line and 2310 feet from the East line of Section 20; and
- (ii) McIntyre "A" Well No. 9 (API No. 30-015-23407), located at an unorthodox oil well location [approved by Division Administrative Order NSL-1214-A (SD), dated August 19, 1998] 2400 feet from the South line and 1600 feet from the East line of Section 20.

This application has been duly filed under the provisions of Division Rule 104.F, revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999.

By the authority granted me under the provisions of Division Rule 104.F (2), the following described well to be drilled at an unorthodox infill oil well location within the subject unit is hereby approved:

Further, Loco Hills-Paddock oil production from the two existing McIntyre "A" Wells No. 3 and 9 and proposed McIntyre "A" Well No. 17 are to be simultaneously dedicated to the subject 40-acre oil spacing and proration unit.
