Re: Maralo, Inc. Request to move location of unorthodox wells,
Jalmat Yates Unit No. 11 and No. 18, Lea County, NM

Gentlemen:

Maralo requests permission to move the unorthodox locations approved by Order No. R-5816-A to drill Jalmat Yates Unit Well numbers 11 and 18 because of their proximity to a natural gas transmission line and a power line respectively.

Order No. R-5816 approved the following unorthodox locations for the subject wells:

- #11 - 50' FNL & 1350' FWL, Section 18, T-25-S, R-37-E
- #18 - 1300' FNL & 2580' FWL, Section 18, T-25-S, R-37-E

Because of an existing natural gas transmission line, it will be necessary to move the location for well number 11 seventy-two feet south (away from our lease line). Well number 18 will need to be moved sixty-one feet west (away from the lease line) to avoid drilling too close to a high voltage power line.

Therefore, we request approval to drill these two wells at the following locations as shown on the attached plat:

- #11 - 122' FNL & 1350' FWL, Section 18, T-25-S, R-37-E
- #18 - 1300' FNL & 2519' FWL, Section 18, T-25-S, R-37-E
