Subject non-standard location was granted for this well September 8, 1981 at a location of 2100' FNL & 1400' FEL (see Exhibit I). It is requested that this order be amended to reflect a revised location of 1946' FNL & 2255' FEL or that a new order be issued due to topography. The original location would require extensive blasting of limestone outcroppings and the BLM has concurred with Mesa in moving the well to the new location which will require no blasting and little cut and fill (see Exhibit II).

Mesa Petroleum Co. operates three additional wells within the section and subject well will be assigned the NE1/4 160 acres if completed in the West Pecos Slope Abo Gas Pool as planned (see Exhibit III). Transwestern Gas (Offset Operator) has been provided a copy of this letter via certified mail.

Expeditious handling of this request is appreciated.


