Grace Petroleum Corporation requests that Administrative Order NSL-1442 approving the drilling of West Tonto "A" Federal Com. No. 1 be amended for approval of a skid well, West Tonto "A" Federal Com. No. 1-Y.

It was necessary to P & A the No. 1 well because of mechanical problems encountered after the 8-5/8" casing was cemented. The approval is requested for a non-standard location 2450' FSL and 660' FWL of Sec. 25, T-19-S, R-32-E, Lea County, New Mexico (30' South of No. 1 and on the same drilling pad).

Attached is a listing of offset owners that are receiving a copy of this letter by Certified mail.

The proposed non-standard location has the verbal approval of the USGS and was spudded 1-25-82 from the same drilling pad from which Archeological Clearance has already been obtained.


Also attached is a copy of Form C-102 showing the dedicated acreage. GPC proposes the unorthodox location to cover the Bone Springs, Wolfcamp, Strawn, Atoka, and Morrow formations.




