

Describe Cause of Problem and Remedial Action Taken.* **2-inch poly flow-line leak. 2-inch poly-line was replaced with 3-inch poly flow-line.**

Describe Area Affected and Cleanup Action Taken.* **The crude oil release site was excavated; the impacted soil was transported to the State Land Farm (98 cubic yards), confirmation soil samples were collected from the excavation. Once the excavation confirmation soil samples were below NMOCD regulatory standards; approximately 98 cubic yards of backfill material was obtained from the landowner and the site was contoured to the original rangeland topography.**






