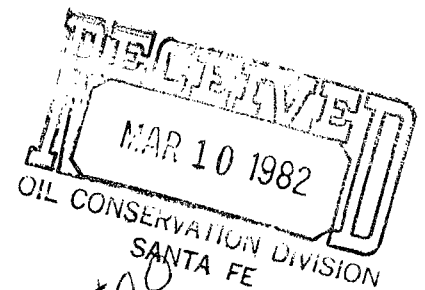

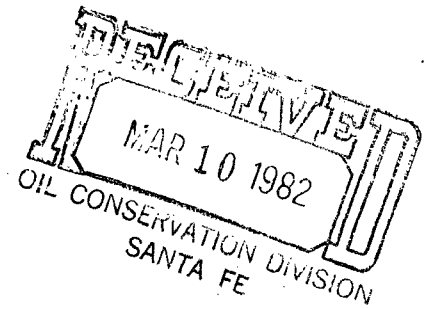

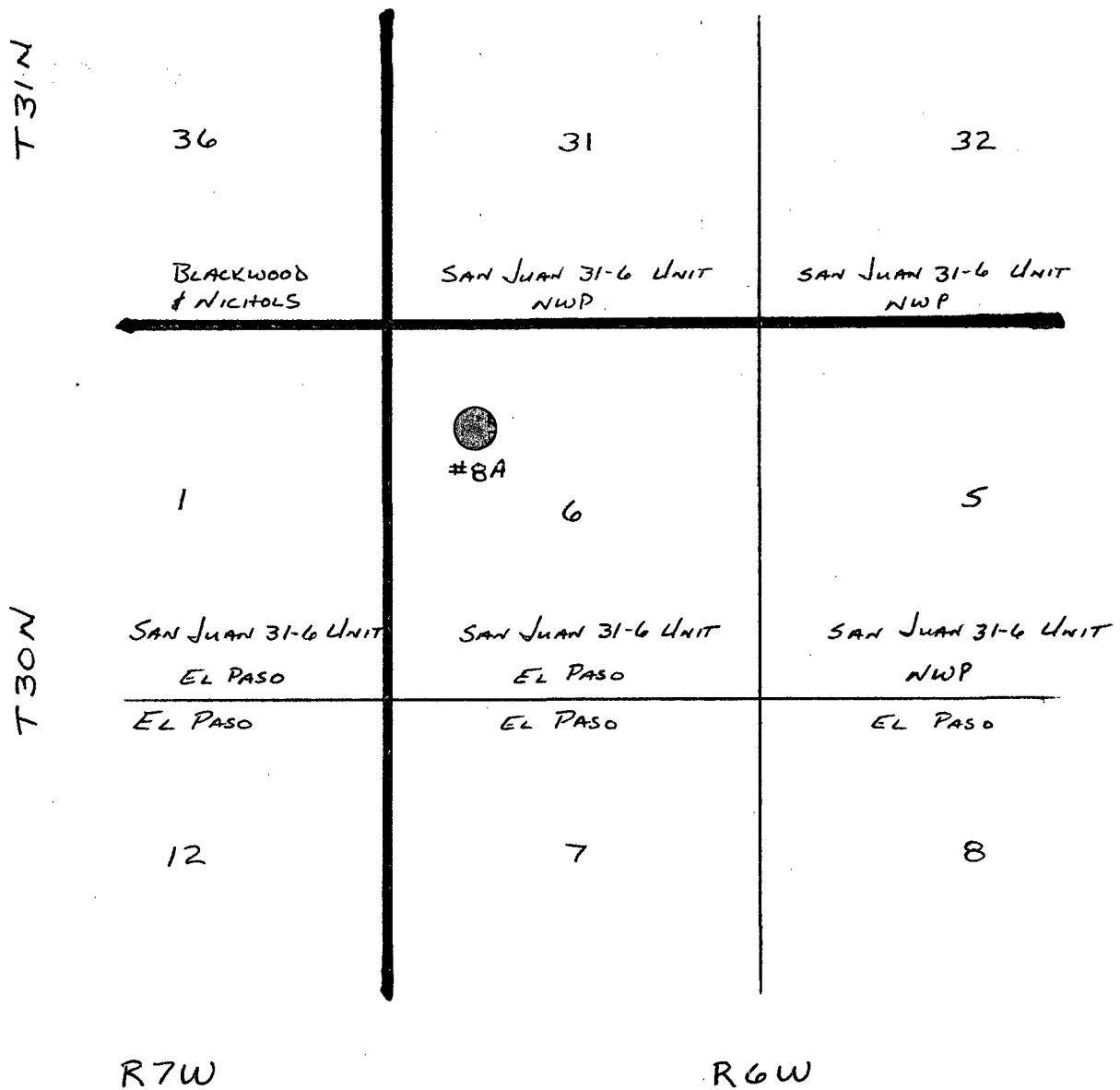

SAN JUAN 31-6 UNIT #8A (MV)



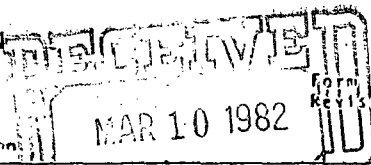

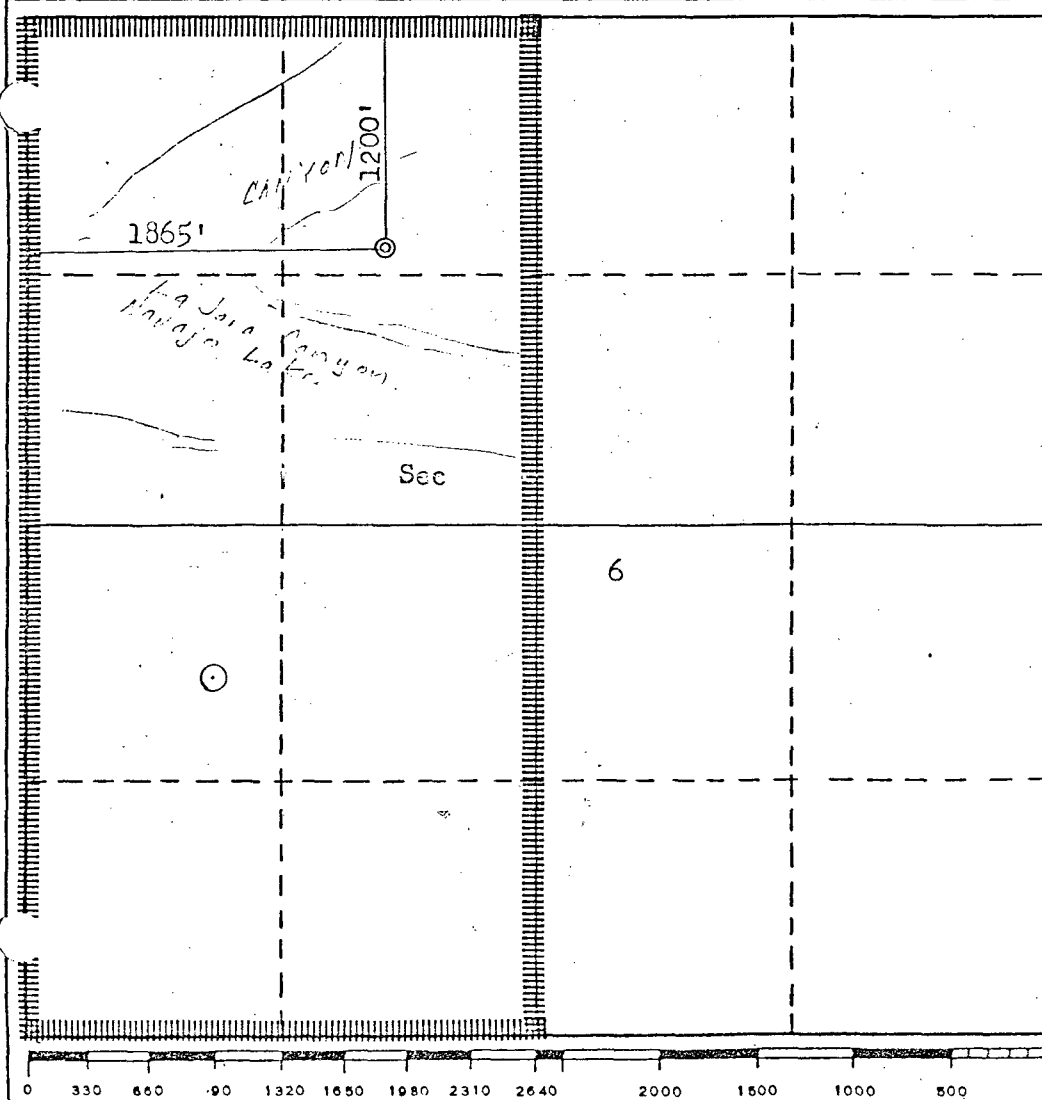

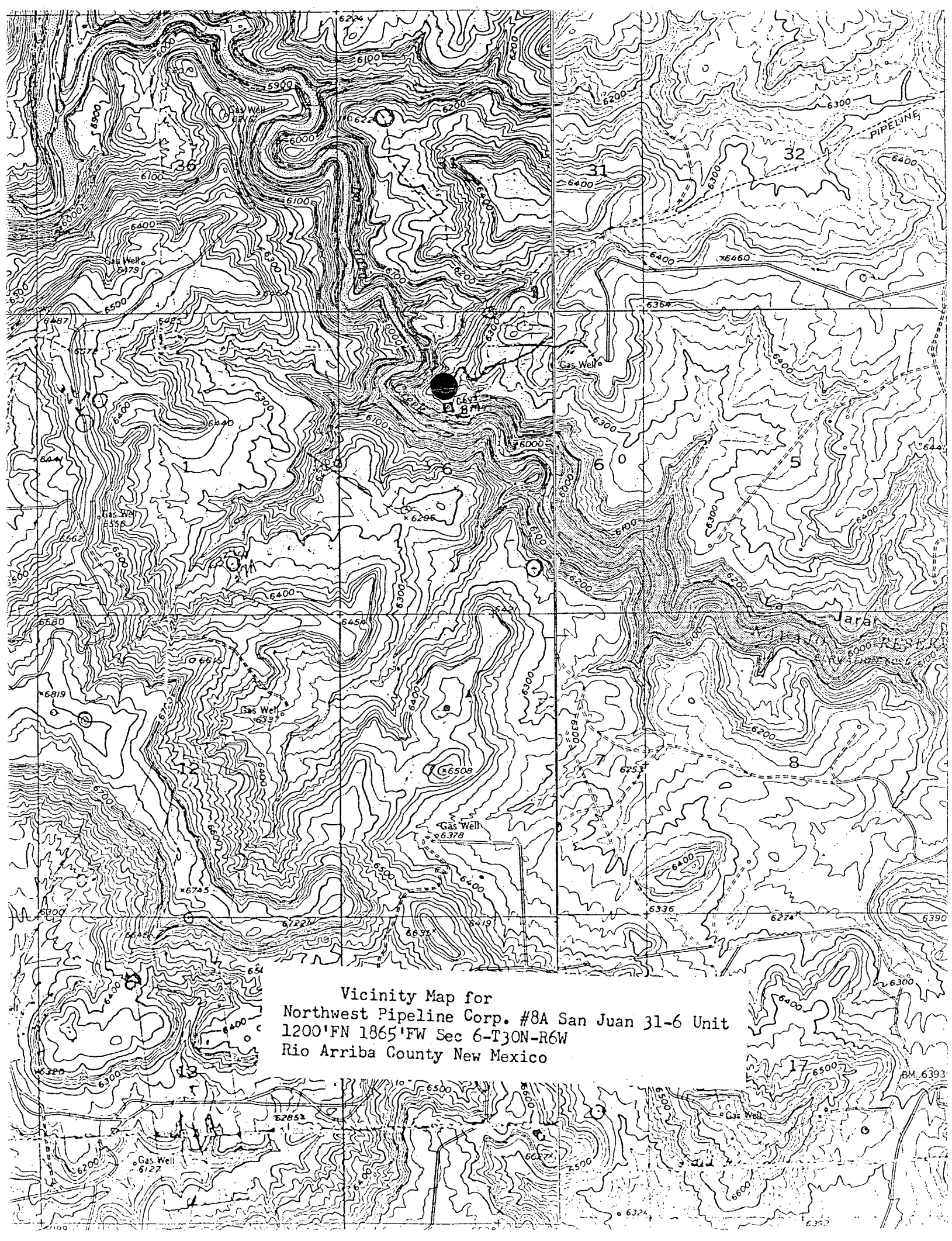

Rio Arriba County New Mexico

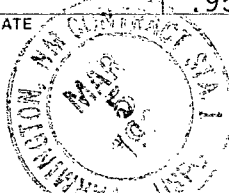

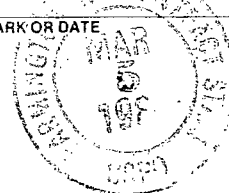

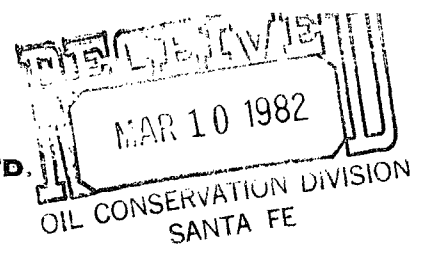
