

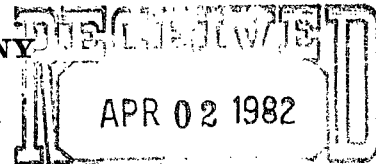

Formation

We are requesting approval of subject unorthodox location due to topographic conditions. We desire to drill this well on the same well pad with the Kimbell Oil Company Warren-Salazar No. 2, a Dakota well, located 825' FSL & 810' FWL of Section 26. On staking the location, we found that the 60 to 80 feet cliffs on the North and East side of the well pad and a 50-60 feet canyon on the West side prevented us from drilling it at a standard location.

Merrion Oil & Gas Corporation, an off-set acreage owner, as shown on the enclosed plat has been notified by certified mail and requested to forward a waiver to you. The remaining offset acreage is operated by Kimbell Oil Company.

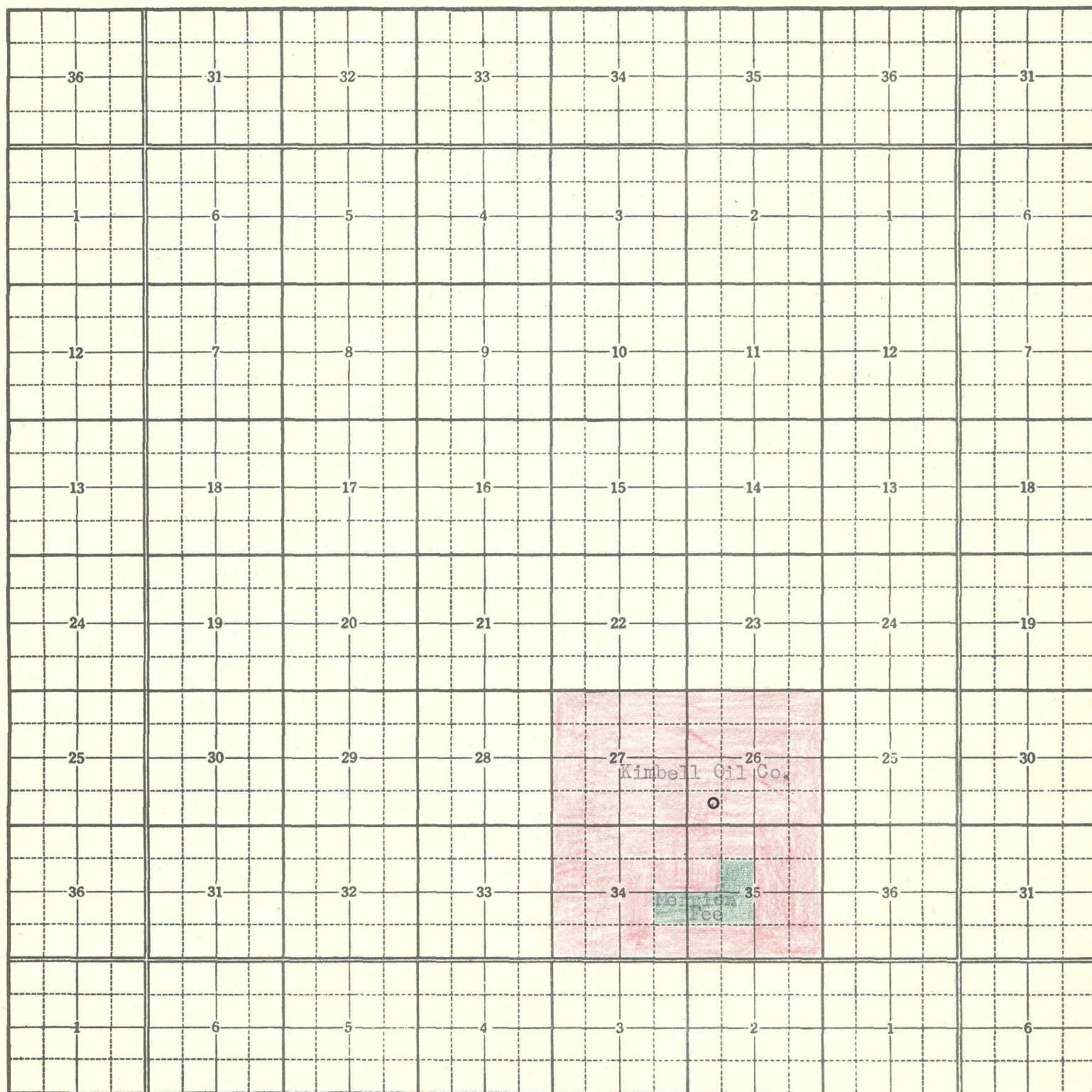

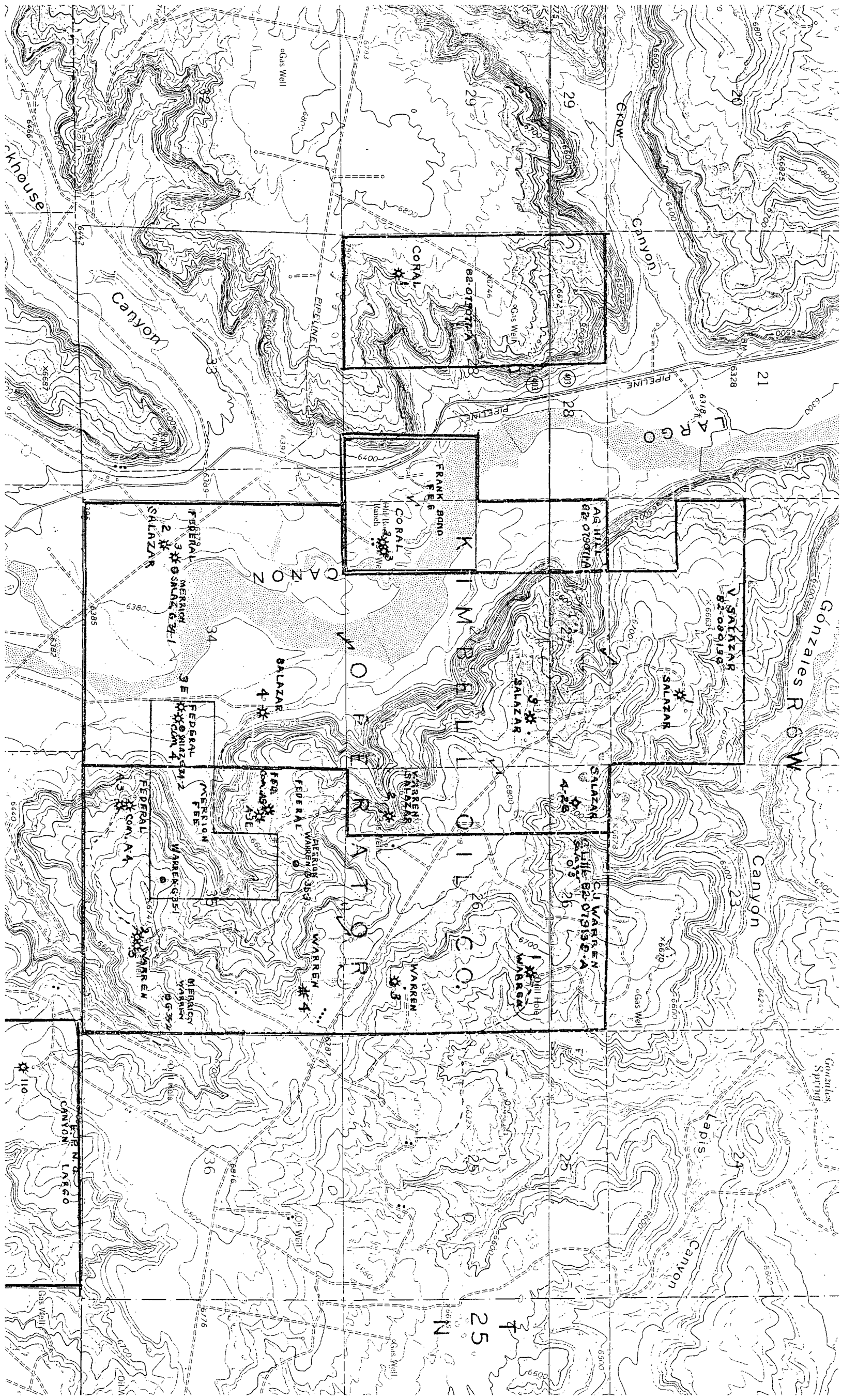


