

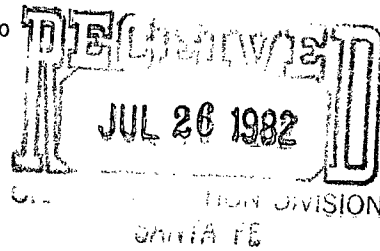

Enclosed you will find a waiver letter concerning the above subject well. 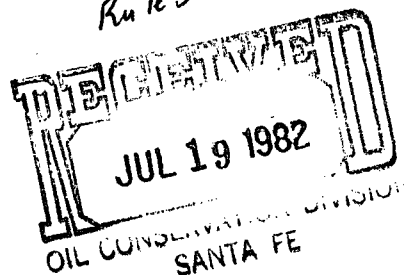

Mr. Ramey:

Earlier this year, C&K proposed the drilling of the captioned well at a location that was abandoned because of the objection of offset operators. Later, a substitute location was also abandoned because it had archaeological problems. The location stipulated above meets all archaeological standards and we have approval of all offset operators with the exception of one. Ms. Corinne Grace, P.O. Box 1418, Carlsbad, New Mexico 88220, who is the easterly leasehold owner and well operator, has not seen fit to answer our correspondence or take our phone calls.

Attached are the necessary forms for the permit to drill the above referenced well. Because of an archaeological problem we are requesting an unorthodox location as follows:

Introduction

An archaeological reconnaissance was recently completed by the Agency for Conservation Archaeology (A.C.A.) at Eastern New Mexico University for C & K Petroleum in Eddy County, New Mexico, on land administered by the Bureau of Land Management. The reconnoitered area will be impacted by the construction of a well pad and its associated access road and an alternate location. The project was administered by Mr. Don Delaney for C & K Petroleum and Dr. Colleen M. Beck, Director of ACA. This report was prepared by the Portales office of ACA.

The field work was conducted on May 16, 1982 by Colleen M. Beck. Excellent field and weather conditions prevailed throughout the course of this reconnaissance. This survey was conducted under Federal Antiquities Permit number 81-NM-223. A search of the National Register has been made and properties within this area are not listed on the Register.

Survey Technique

Visual inspection of each pad was completed by walking a series of parallel transects. Each transect was covered in a tightly spaced zigzag pattern. All access roads were examined as two individual transects, with tightly spaced zigzag patterns covering the length and breadth. The distance between transects was 25 feet (7.6 meters). This method maximized the opportunity of observing any cultural resources within or near the proposed area of impact.

Exxon-Williams Fed. #2 & Road

Location

The proposed well pad and access road are located .3 miles northeast of White's City, New Mexico, in the Pecos River Valley. The pad measures 400 X 400 feet (121.9 X 121.9 meters) and the access road measures 50 X 1400 feet (15.2 X 426.7 meters). They are situated as follows:

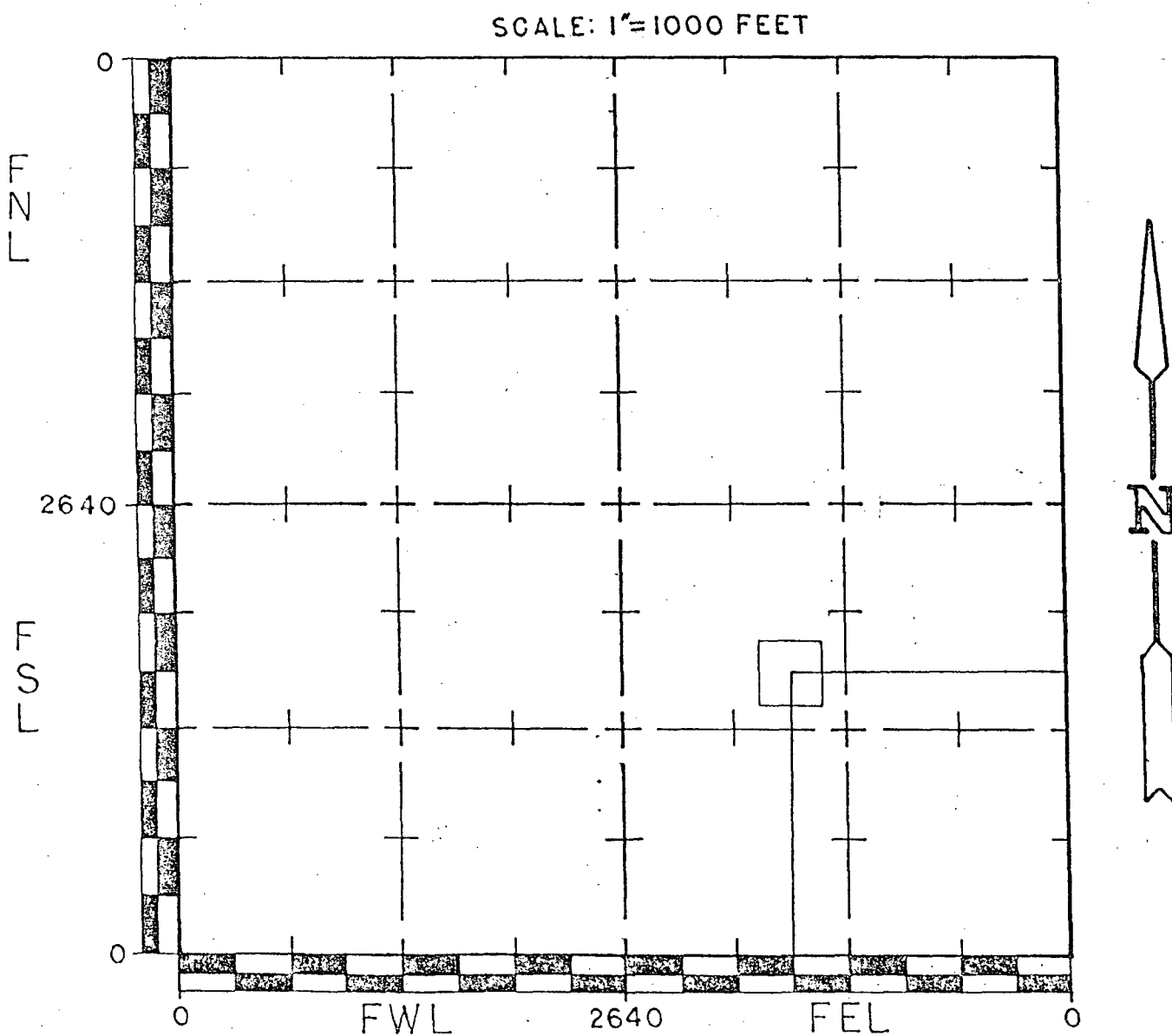

Terrain

The proposed well pad and access road are located in the Pecos River Valley, .3 miles west of Jurnigan Draw. It is situated on a gentle colluvial slope. The elevation varies from 3425 to 3435 feet (1043.9 to 1046.9 meters). The soil encountered in the area is predominantly a calcareous sandy loam. Taxonomically, it can be classified as a calciorthids. Lithic inclusions consist of 20 to 80% medium sized caliche fragments.

Floristics

ACA encountered a dense floral assemblage at this location. The density of the vegetation in the area is approximately 80 percent, consisting primarily of grasses. The dominant species are mixed grasses. Among other species present are Engleman pricklypear (Opuntia phaeacantha), mesquite (Prosopis juliflora), sand sage (Artemisia filifolia), and other unidentified species.

Cultural Resources

During the course of this reconnaissance, ACA recorded one archaeological site, ENM 10671. However, no isolated manifestations were encountered.

Site Description: ENM 10671 is a dense scatter of burnt and unburnt caliche on a colluvial slope. The concentration is at surface level but is

not natural. Therefore, the site appears to be a deflated/eroded ring midden. No other artifacts were associated with the caliche.

The density of caliche fragments at ENM 10671 ranges from a minimum of 10 per square meter to a maximum of 50 per square meter. A diffuse scatter of caliche occurs around the site area, particularly to the south. In fact, the scatter continues for at least 120 meters to the south. These fragments probably have been washed downslope from the site (Figure 3).

Although the ring midden had been disturbed, it is possible that subsurface remains of the ring itself and charcoal are present. The northern boundary of the proposed pad bisects the site and avoidance is recommended.

A review of the National Register did not find any properties listed for this location.

Recommendations

Although the ring midden appears deflated, there is potential for subsurface remains in the ring midden area. ACA recommends avoidance and suggests that the company use the alternate location.

The proposed well pad and access road are located .3 miles northeast of White's City, New Mexico, in the Pecos River Valley. The pad measures 400 X 400 feet (121.9 X 121.9 meters) and the access road measures 50 X 1600 feet (15.2 X 487.7 meters). They are situated as follows:

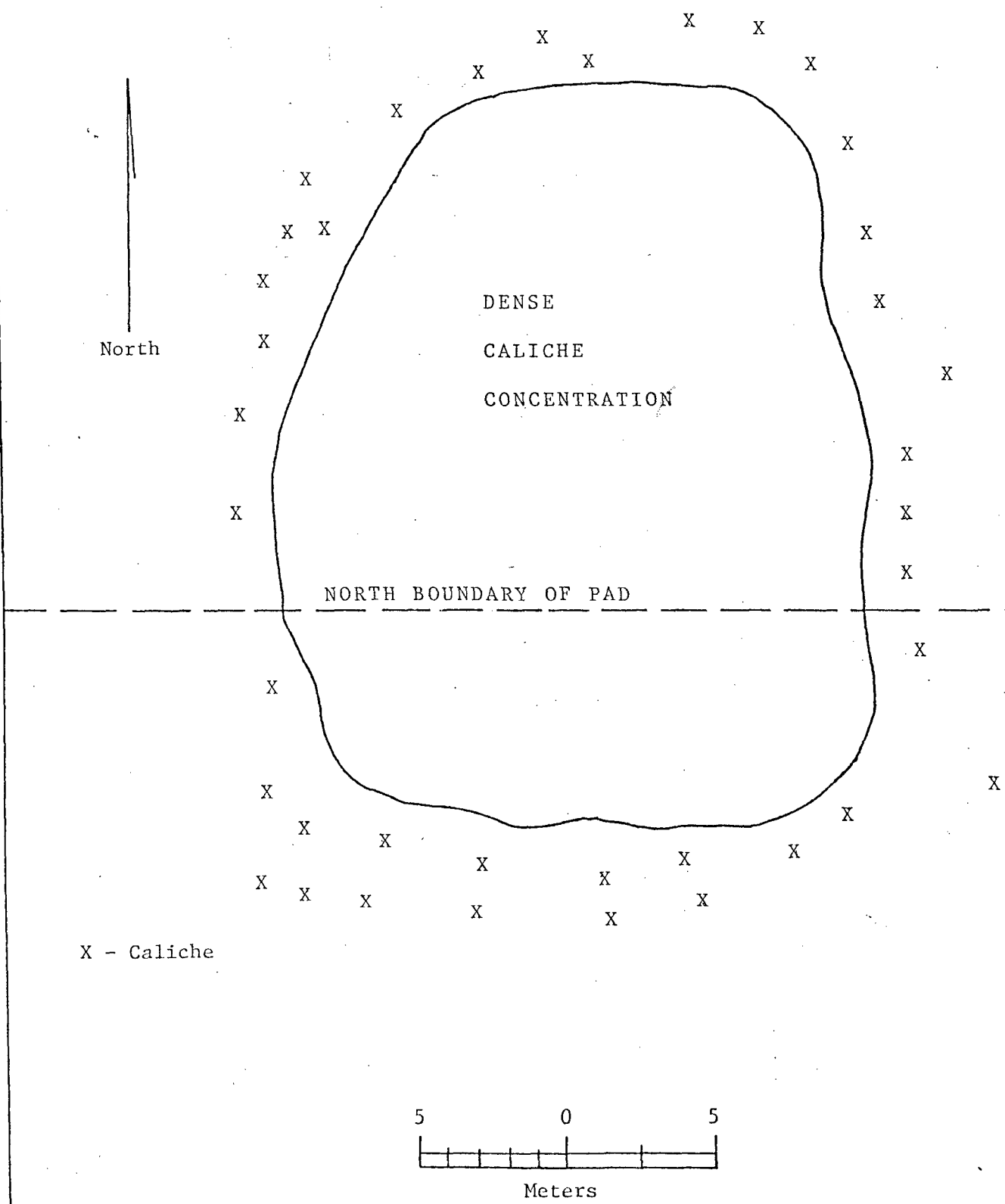

Terrain

Cultural Resources

During this survey ACA did not encounter any archaeological sites. However the following isolated manifestation was recorded:

IM-1: is a broken uniface (5 X 4 X 2 cm) of fine grained maroon quartzite, found 90 feet west and 20 feet north of the southeast corner of the pad (collected).

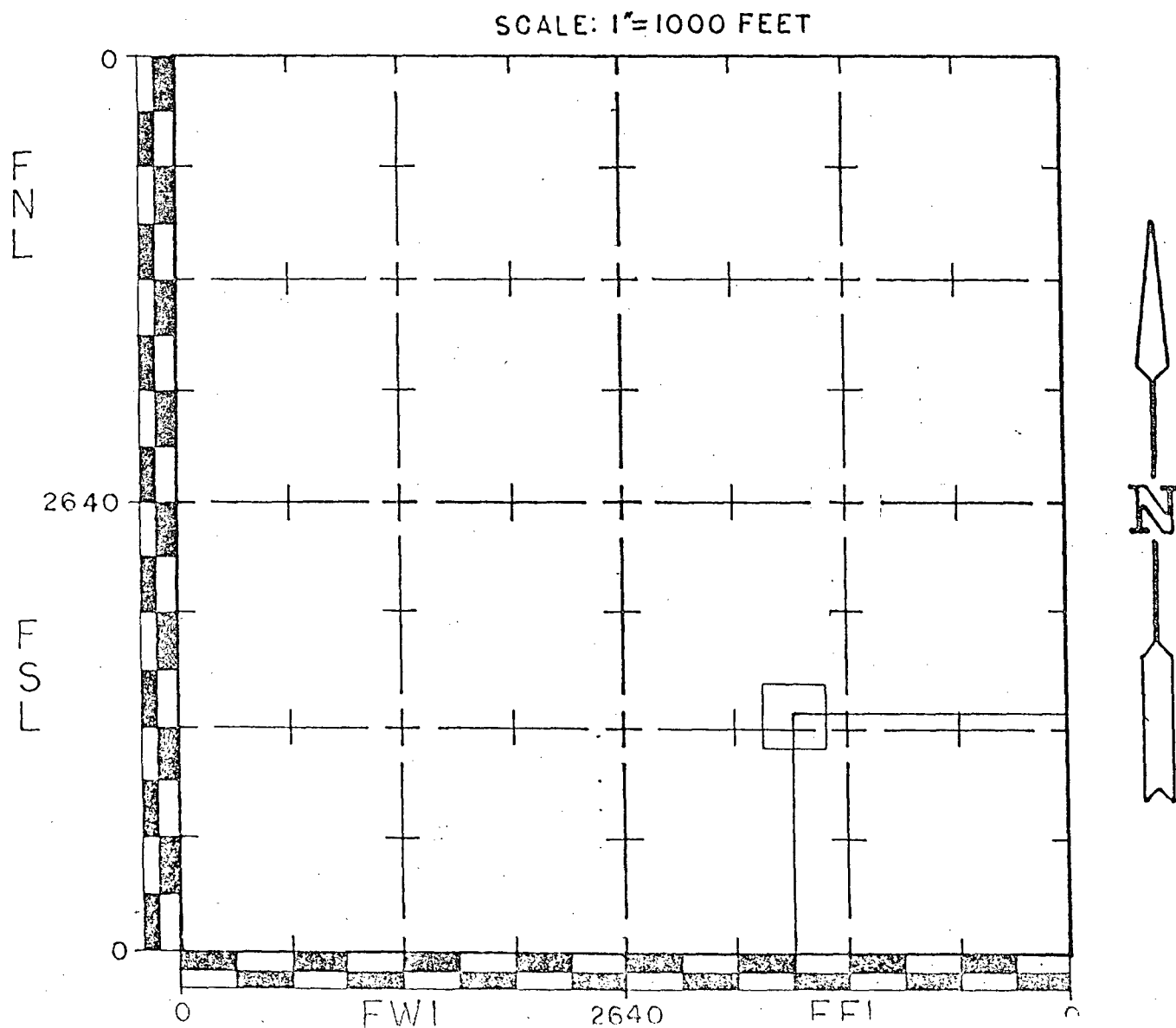
A review of the National Register did not find any properties listed for this location.

Recommendations

There are no significant cultural resources; therefore, ACA recommends clearance for the proposed well pad and access road and suggests that construction be allowed to proceed as currently planned.

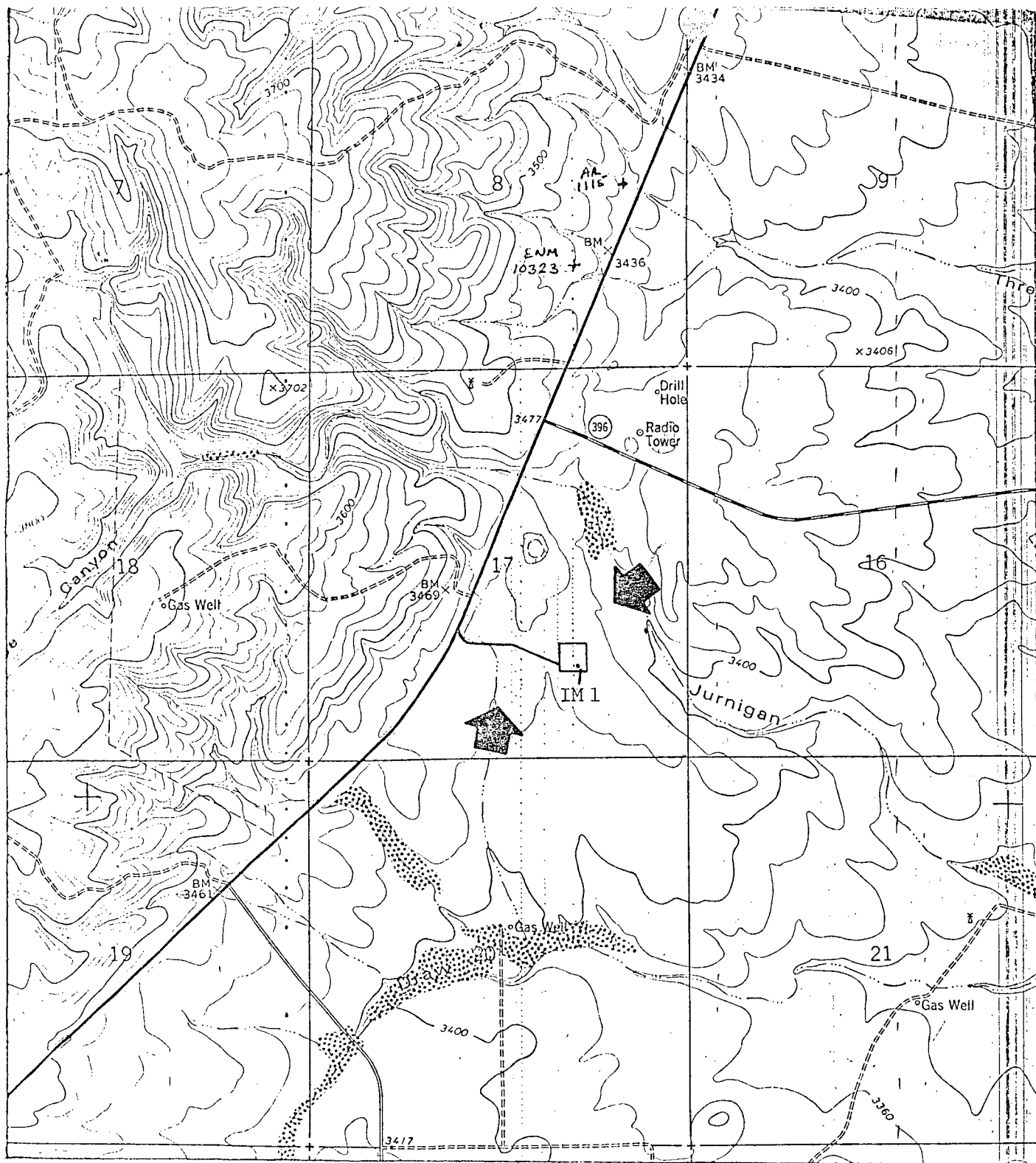
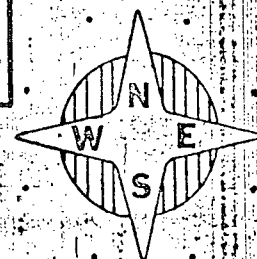


Figure 5: Location of Alternate Exxon-Williams Federal
