Yates Petroleum Corporation would appreciate an administrative approval for a proposed unorthodox Undesignated Wolfcamp reentry as provided for under NMOCD Rule 104F.

We are proposing to reenter a well drilled by Lario Oil and Gas Co. (Superior Federal Gas Com #1 - P&A 12/16/72). Lario originally dedicated 640 acres to this well. Our dedication will be 320 acres, therefore resulting in an unorthodox location.
