



Describe Cause of Problem and Remedial Action Taken.\*  
During an intense lightning storm, the tank battery was ignited by a lightning bolt. This caused the two 500 barrel fiberglass oil storage tanks to ignite followed by the explosion of the 500 barrel produced water storage tank. The oil storage tanks had approximately 450 barrels of crude oil while the water storage tank had less than 30 barrels of water. The water was contained within the firewall and evaporated while the oil contained in the storage tanks burned. All three tanks were grounded with copper wiring. The tank battery will be replaced. Extensive grounding for lightning protection will be installed.

Describe Area Affected and Cleanup Action Taken.\*  
The affected area outside the firewall covered approximately 100 ft by 150 ft. Damage consisted mainly of burnt surface material with slight staining of plants by smoke. All contaminated material was removed to a depth of 2" below surface and shipped to an aerated land farm. Fresh, uncontaminated material was placed in the affected area and leveled to the contour of the location. The material inside the firewall was removed, sent to an aerated land farm, and replaced with fresh material.
