Amended Location 2501' FSL & 1410' FWL

The certified plat submitted with this request indicates the amended location.

Administrative Order NSL-1891 previously approved an amended location to that which was entered in Exhibit "A" of NMOCD Order No. R-7628. The latter order granted approval of our application to drill 35 wells at unorthodox locations. As stated in our original application, these producers will be located less than the minimum 330 feet from 40-acre proration unit boundaries, but are orthodox in all other respects.

Inasmuch as the basis of our original application remains unchanged, we recommend your approval of Shell's proposal to drill this infill producer at the amended, less unorthodox location as shown above.
