

Dear Mr. Stamets:

This is a request for administrative approval for an unorthodox gas well location in the Blanco Mesa Verde Pool.

It is intended to locate the El Paso Natural Gas Company's San Juan 27-5 Unit #34A at 1930' from the North line and 980' from the West line of Section 30, T-27-N, R-5-W, Rio Arriba County, New Mexico.

Extremely rough terrain in the form of steep cliffs and the existence of Cereza Canyon in the Northwest corner of this section makes it impossible to build an orthodox gas well location.

El Paso operates all proration units offsetting the proposed unorthodox location.

Plats showing the proposed well location and the terrain in Section 30, along with an ownership plat, are attached.
