

McClellan Oil Corporation would appreciate an administrative approval for a non-standard Morrow gas well location as provided for under NMOCD Rule 104, F (I).

The proposed SAM Fed. No. 1, located 660' FNL & 330' FWL of Section 28, is a re-entry of the Texaco Spencer "B" Fed. No. 1. The subject well is to be recompleted in the Morrow with the north half of section 28 dedicated to the well. The Texaco well was originally drilled on a standard oil well location.

The enclosed lease map shows the offset operators who have been notified by certified mail of our request.

In your letter of February 12, 1985, Texaco requested that McClellan Oil Corporation agree to a non-standard location for the proposed re-entry of the Texaco Peery Federal No. 4, located in the $NE\frac{1}{4}NE\frac{1}{4}$ of Section 29, Township 15 South, Range 30 East, Chaves County, New Mexico.
