

Dear Mr. Stamets:

This is a request for administrative approval for an unorthodox gas well location in the Basin Dakota Pool.

It is intended to locate the El Paso Natural Gas Company's San Juan 29-7 Unit #130 at 2025' from the South line and 1400' from the West line of Section 21, T-29-N, R-7-W, Rio Arriba County, New Mexico.

The Bureau of Land Management requested this well be drilled at the proposed location due to archaeological consideration of an Indian ruins in the southwest corner of Section 21. Furthermore, steep cliffs and an existing pipeline in this quarter section makes it impossible to build an orthodox location.

El Paso Natural Gas Company operates all proration units offsetting the proposed unorthodox location.

Plats showing the proposed well location and the terrain in Section 21, along with an ownership plat, are attached.
