

MANCHESTER STATE UNIT #1

To Whom It May Concern:

The Manchester State Unit #1 is making 180 mcf/d (1100 btu gas) from the Morrow. The proposed Upper Penn interval will also be 1100 btu gas and I estimate will contribute an additional 300 mcf/d.

The DHC is needed to prevent waste and enable higher cums with extended well life. These intervals are compatible and neither will be damaged by the proposed commingle. Thank you.
