Enclosed, please find copies of a final C-141 report and results for sampling conducted on July 14, 2006 at the above captioned location. Field soil vapor headspace measurements were taken with a PID Meter on grab soil samples.

Following are the results of testing.

Sample 001, approximately 5' NW of the water tank, 24" depth, VOC – 45.2 ppm.
Sample 002, approximately 10' west of the water tank, 36" depth, VOC – 4.7 ppm.
Sample 003, approximately 3' north of the water tank, 12" depth, VOC – 89.8 ppm.

With these results, Yates Petroleum Corporation requests closure of the site.


