Energen Resources Corporation (Energen) hereby requests Administrative Approval for an Unorthodox Location of its San Juan 30-4 #33C Mesaverde formation well under the provisions of New Mexico Oil Conservation Division, Blanco Mesaverde Gas Pool rules.

This well is located in the SW/4 of Section 31-T30N-R4W, Rio Arriba County, New Mexico and is dedicated to a spacing unit consisting of the W/2 of Section 31, (Lots 1, 2, 3, 4, E/2W/2), containing 205.88 acres. This spacing unit was approved by order R-1670, and is a very narrow spacing unit.

This well is located closer than 660' from the eastern proration unit boundary by 637'. This well is within the boundaries of the San Juan 30-4 Unit. This location was drilled due to topography and archeological issues. Energen also located this well to stay an appropriate distance from other Mesaverde wells.

Energen is the operator of the affected offsetting spacing unit, and as a result of this well being located within the Mesaverde Participating area of the San Juan 30-4 Unit, the working interest ownership of both this spacing unit and the affected spacing unit are identical. An affected owner letter is being sent out with a request for waivers within a 20 day period.
