Request for Unorthodox Location - Baish A No. 14, 810' FNL & 500' FWL, Section 22, T17S, R32E, Lea County, NM. Maljamar Abo & Baish Wolfcamp Pools.

Conoco Inc. respectfully requests administrative approval to drill the subject well at an unorthodox location in Unit D, 810' FNL & 500' FWL of Section 22, T17S, R32E, Lea County, New Mexico. This well will be the second well on the proration unit for both pools.

The unorthodox location for the subject well is necessary to avoid an existing well location and an existing powerline. The existing well location is the plugged and abandoned MCA Unit No. 30 (660' FNL & 660' FWL). The existing powerline is located approximately 135' north of the proposed location and runs east and west.

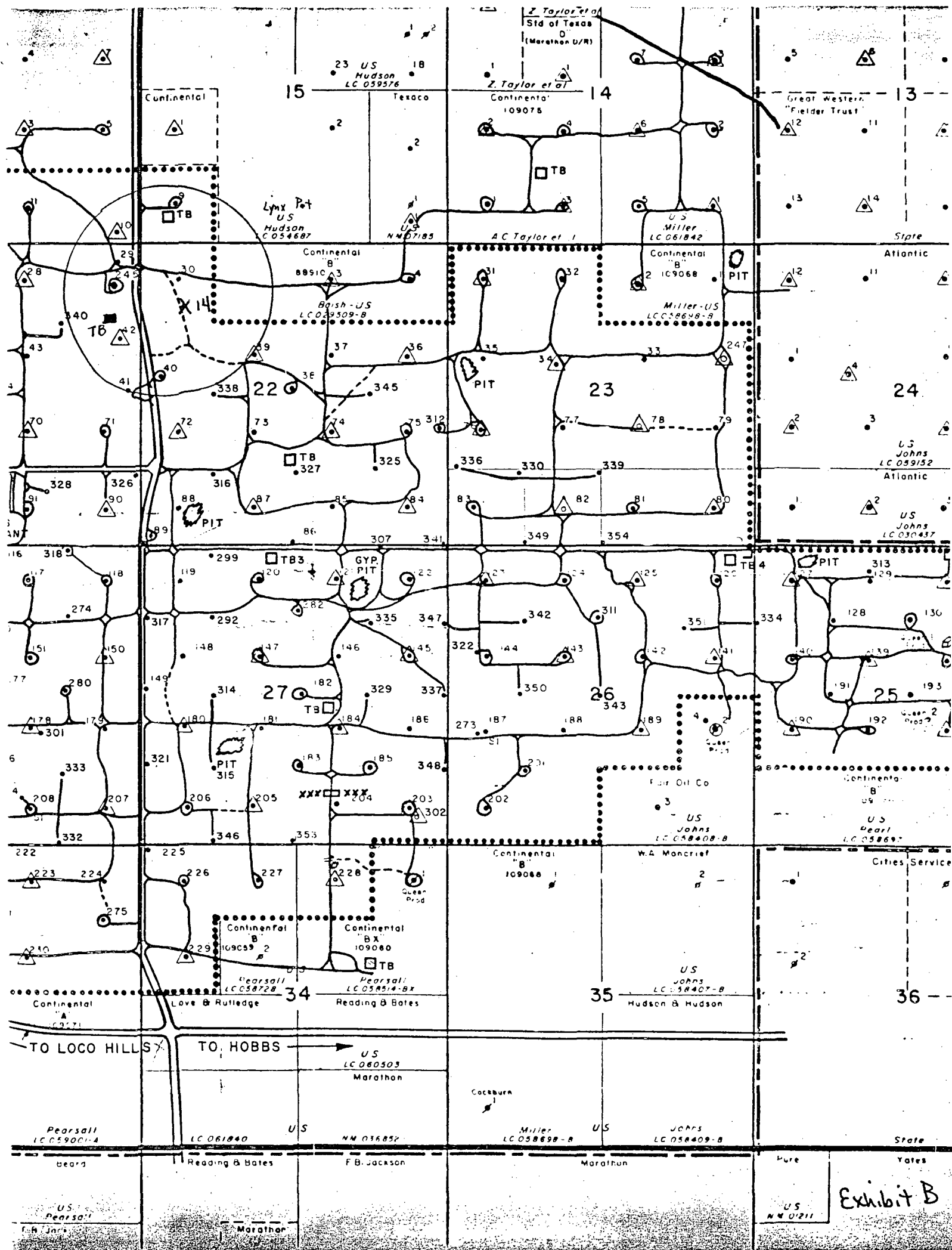
Conoco offsets this proposed location with the exception of the northeast corner of the proration unit.
