Reference is made to your application of September 14, 1988 for a non-standard gas well location for your Jicarilla "22" Well No. 12-A to be located 2080 feet from the South line and 2290 feet from the West line (Unit J) of Section 15, Township 25 North, Range 4 West, NMPM, Blanco Mesaverde Pool, Rio Arriba County, New Mexico. This is an Infill Well to the applicant's Jicarilla "22" Well No. 12 located at a standard gas well location 1650 feet from the North line and 850 feet from the East line (Unit H) of said Section 15. Both wells to be dedicated to a standard 320-acre gas spacing and proration unit comprising the E/2 of said Section 15.

By the authority granted me under the provisions of Rule 2c of Division Order No. R-8170, as amended, the above-described unorthodox gas well location is hereby approved.
