Yates Petroleum hereby makes application for administrative approval for exception to the Standard Gas Well Location for re-entry of the Carper Drilling Company's Monsanto State No. 1, located 660 feet from North and East lines of Section 33 T17S R24E, Eddy County. Subject well was permitted for Max Wilson in February 1964 on 40-acre spacing and designated as State Marathon Well No. 1. The well was subsequently drilled as a Cisco-Canyon exploratory well to a depth of 7020 feet by Carper Drilling Company and plugged and abandoned in May 1964 not having encountered commercial oil pay.

Subject re-entry will be an extension of the Collins Ranch Wolfcamp gas field. Dedicated acreage would be the North half of Section 33 and Yates Petroleum is the operator of all offset acreage. It is further noted that undesignated Cisco Canyon gas was discovered in YPC - Richard Knob AEK State No. 1, located 1980 feet from the North & East lines of Section 34, T17S-24E. Also, there were shows in the Strawn and Atoka-Morrow formations.

Yates Petroleum has scheduled for drilling an offset to the Richard Knob AEK No.1. The re-entry and deepening of subject well will allow us to "look at" the potential of the Morrow and intermediate horizons and would greatly affect the location of the Richard Knob AEK State No. 2. This non-standard location will prevent waste and does not infringe on correlative rights of operator or mineral owner.

This request for Administrative Approval of an Unorthodox Gas well location is submitted as provided for under NMOCD Rule 104 F. Topographically, this location is closer to the gas transmission line than a standard location would be since Transwestern Pipeline is approximately 1/2 mile North, running 25-30 degrees West and North from the State DF No. 1 in Unit D of Section 35, 1175-R24E, Note that the State DF No. 1 was approved administratively by Order NSL-895 on November 1, 1977.




