

Dear Mr. Stogner:

Per our phone conversation of Friday, March 24, 1989, S & J Operating Company respectfully requests an exception to the spacing requirement for the above referenced well.

As the attached plat shows, we have applied for a drilling location 1,010' from the west line and 240' from the south line of Sec. 36, T17S, R27E. There is an Arco well located at approximately 1,010' from the west line and 330' from the south line called the Empire (Abo) Unit "H" No. 17. This well is a pressure observation well in the Abo formation at approximately 5800'. There is also a shallow producing oil well which is operated by Joe Tarver and is located west southwest of the Arco well. This well produces oil from a depth of 600' - 900'.

The South Red Lake Grayburg Unit well No. 48 is a development well in the secondary recovery project known as the South Red Lake Grayburg Unit. This well is needed to obtain production which has been swept to this area by injection wells to the east, west and south.

If any further information is needed to obtain this exception, please let me know.

**NOW,** on this 5th day of March, 1965, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

**FINDS:**

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) (As amended by Order No. R-2875-A, August 16, 1965.) That the applicant, Archie M. Speir, seeks approval of the South Red Lake Grayburg Unit Agreement covering 1442.34 acres, more or less, of State and Federal lands described as follows:
