Gentlemen:

American Exploration Company proposes to drill and complete a 1700' Upper Hospah Sand Unit test in the Hospah Field, McKinley County, New Mexico, located in Unit Letter N, 1750' FWL and 70' FSL of Section 36, T18N, R9W as outlined and surveyed on Forms C101 and 102.

Pursuant to Rule 104, Sec. II, (F) (I), provides that a permit for the completion of an efficient productive well within a secondary recovery or pressure maintenance may be administratively approved by the Division Director as an exception to the well location requirements of Sections B and C without notice or hearing. It further provides that such location within the project is no closer than 330 feet to the outer boundary of the unitized area, nor closer than 10 feet to any quarter-quarter section line.

The well location and acreage dedication plat for the referenced well falls within the provisions for an Unorthodox Location as noted above. Therefore, American Exploration Company respectfully requests approval for our Application for Permit to Drill this unit test.
