Gentlemen:

An Exception to Rule 104 C.I. by administrative approval is requested for Texaco Producing Inc.'s Vacuum Grayburg San Andres Unit Well Nos. 148, 152, 153, 154, and 155. The wells are located as follows:

Well No. 148: 1330' FNL, 660' FWL, Sec. 1, T-18-S, R-34-E  
Well No. 152: 640' FNL, 1310' FWL, Sec. 2, T-18-S, R-34-E  
Well No. 153: 660' FNL, 2630' FWL, Sec. 2, T-18-S, R-34-E  
Well No. 154: 660' FNL, 1331' FEL, Sec. 2, T-18-S, R-34-E  
Well No. 155: 660' FNL, 10' FEL, Sec. 2, T-18-S, R-34-E

The wells must be drilled in these locations to ensure proper development of 20-acre spacing. Wells drilled previously on 20-acre spacing on our adjacent Central Vacuum Unit have proven to be viable wells. These wells will be completed in the Grayburg San Andres formation. They are offset by Phillips Petroleum Company and they have been notified of these applications.

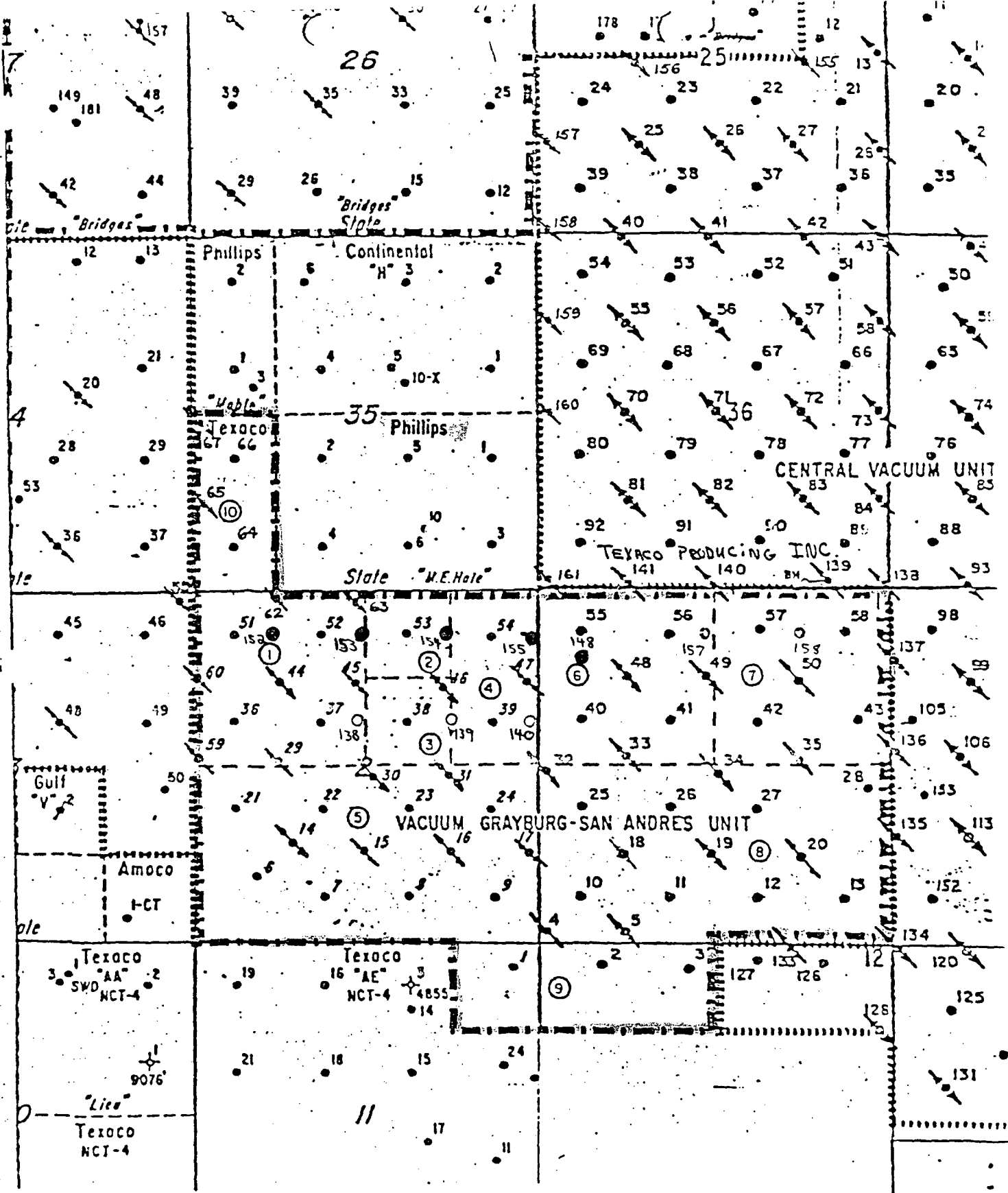


