Reference is made to your application of March 23, 1990 for an unorthodox well location for the Undesignated South Dagger-Draw-Upper Pennsylvanian Associated Pool, Eddy County, New Mexico.

By Division Order No. R-9015, dated October 12, 1989, authorization was given the applicant to drill their Saguaro "AGS" Federal Com. Well No. 1 at an unorthodox gas well location 1980 feet from the South line and 660 feet from the West line (Unit L) of Section 11, Township 20 South, Range 24 East, NMPM, to test the Undesignated Cemetry-Morrow Gas Pool, Eddy County, New Mexico. It is my understanding that at this time Yates proposes to plug-back from the Morrow zone and recomplete this well up-hole in the Canyon formation whereby the S/2 of said Section 11 shall be dedicated to said well forming a standard 320-acre gas or oil spacing and proration unit for said pool.

By the authority granted me under the provisions of the General Rules and Regulations for the Associated Oil and Gas Pools of Northwest and Southeast New Mexico/South Dagger Draw-Upper Pennsylvanian Associated Pool Rules as promulgated by Division Order No. R-5353, as amended, the above-described unorthodox location is hereby approved.

Reference is made to your application dated April 12, 1990 for an unorthodox oil well location for the Undesignated South Dagger-Draw Upper Pennsylvanian Associated Pool in the S/2 of Section 11, Township 20 South, Range 24 East, NMPM, Eddy County, New Mexico.

By Division Administrative Order NSL-2773, dated March 23, 1990, the applicant's Saguaro "AGS" Federal Com Well No. 1 was approved as an unorthodox oil well location 1980 feet from the South line and 660 feet from the West line (Unit L) of said Section 11, for the Undesignated Dagger-Draw Upper Pennsylvanian Associated Pool, whereby the S/2 of said Section 11 was dedicated to said well forming a standard 320-acre gas or oil spacing and proration unit for said pool.

It is our understanding at this time that Yates is seeking to re-enter the Conoco, Inc. Debbie Well No. 1 located 1980 feet from the South line and 660 feet from the East line (Unit I) of said Section 11 and recomplete in the South Dagger-Draw Upper Pennsylvanian Gas Pool, whereby the production form said pool in the S/2 of said Section 11 will be simultaneously dedicated to both aforementioned wells.

At this time, the applicant has made a proper filing pursuant to the General Rule and Regulations for the Associated Oil and Gas Pools of Northwest and Southeast New Mexico/South Dagger Draw-Upper Pennsylvanian Associated Gas Pool Rules as promulgated by Division Order No. R-5353, as amended, therefore the above-described unorthodox location and simultaneous dedication request is hereby approved.
