Dear Ms. Atwater:

I am unable to administratively approve the subject well location at this time. Ordering Paragraph No. (2) of Division Order No. R-2729, as amended, requires that a well within a secondary recovery project be at least 5 feet from any interior quarter-quarter section line; the No. 193 well is on the quarter-quarter section line between the SE/4 SW/4 and SW/4 SE/4 of said Section 28.

If possible, could this location be moved to satisfy the requirements? If not, this location will unfortunately require a hearing before authorization by this Division can be made.

I will hold this well from any action the Division takes on this matter until I hear from you.


Administrative Order NSL-2777

Dear Ms. Atwater:

Reference is made to your application dated March 19 and April 2, 1990 for a non-standard oil well location to permit the completion of an efficient production/injection pattern within an existing secondary recovery project for your West Pearl Queen Unit Well No. 193 to be located 100 feet from the South line and 2630 feet from the West line (Unit N) of Section 28, Township 19 South, Range 35 East, NMPM, Pearl Queen Pool, West Pearl Queen Unit Waterflood Project Area, Lea County, New Mexico. The SE/4 SW/4 of said Section 28 shall be dedicated to said well forming a standard 40-acre oil spacing and proration unit for said pool.

By the authority granted me under the provisions of General Rule 104 F(I) and Division Order No. R-2729, as amended, the above-described unorthodox oil well location is hereby approved.


Amended Administrative Order NSL-2777

Dear Ms. Atwater:

Reference is made to your request dated April 17, 1990 to amend the location of your proposed West Pearl Queen Unit Well No. 193 which was previously authorized by Division Administrative Order NSL-2777, dated April 10, 1990. It is our understanding that this amendment is necessary because the surveyor inadvertently overlooked an existing pipeline. At this time, the applicant has made a proper filing pursuant to Division General Rule 104.F.III and IV, and Division Order No. R-2729. Therefore, said Order NSL-2777 shall be amended to reflect an unorthodox location 100 feet from the South line and 2580 feet from the West line (Unit N) of Section 28, Township 19 South, Range 35 East, NMPM, West Pearl-Queen Waterflood Project Area, Pearl-Queen Pool, Lea County, New Mexico.

All other provisions of said Order NSL-2777 shall remain in full force and effect until further notice.
