Pursuant to Division Rule 104.F(2), Devon Energy Production Company, L.P. applies for approval of an unorthodox location for the following well:

<u>Well:</u>	Condor 8 Federal Well No. 1H
<u>Surface location:</u>	1770 feet FNL & 2525 feet FWL
<u>Entry point:</u>	1802 feet FNL & 2394 feet FWL
<u>Bottom hole location:</u>	2310 feet FNL & 330 feet FWL
<u>Well unit (project area):</u>	S½NW¼ of Section 8, Township 18 South, Range 27 East, N.M.P.M., Eddy County, New Mexico

Applicant proposes to drill the well to test the Glorieta-Yeso formation (Red Lake Glorieta-Yeso Pool). The pool is spaced on 40 acres, with wells to be located no closer than 330 feet to a quarter-quarter section line. A portion of the APD for the well, with a Form C-102, is attached as Exhibit A.


The well is located in an area of high relief (see Exhibit A), and the surface location is unorthodox due to topography and existing wellbores. The surface is federally owned, and the surface location is the one to which the Bureau of Land Management would agree. The unorthodox entry point at the top of the Glorieta-Yeso formation is due to the design of the horizontal wellbore.

The entire project area (the S½NW¼ of Section 8), in the Glorieta-Yeso formation, is covered by Federal Lease LC 070678(a), which has common interest ownership. Exhibit B. The affected

offset acreage (the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 8) is covered by Federal Lease NM 118703, in which the only two interest owners are the federal government and applicant. Exhibit C. Therefore, there is no adversely affected interest owner, and notice of this application has not been given to anyone.






