ASE 12303: (Readvertised)

Application of Raptor Resources, Inc. for three unorthodox infill gas well locations, Lea County, New Mexico. Applicant seeks exceptions to the well location requirements provided within the "*Special Rules and Regulations for the Jalmat Gas Pool*", as promulgated by Division Order No. R-8170, as amended, for three unorthodox Jalmat infill gas well locations within an existing non-standard 480-acre gas spacing and proration unit [approved by Division Order No. R-9073, dated December 14, 1989 (paragraph No. 4 of Exhibit A)] comprising the N/2 and the SW/4 of Section 9, Township 22 South, Range 36 East, which is located approximately 8 miles west by south of Eunice, New Mexico. The three existing: (i) State "A" A/C-2 Well No. 4 (API No. 30-025-08853), located at an unorthodox Jalmat infill gas well location 660 feet from the South and West lines (Unit M) of Section 9, which was the subject of Division Administrative Order NSL-2872-C (SD), dated July 6, 1999; (ii) State "A" A/C-2 Well No. 30 (API No. 30-025-08855), located at an unorthodox Jalmat infill gas well location 1980 feet from the North line and 660 feet from the West line (Unit E) of Section 9; and (iii) State "A" A/C-2 Well No. 48 (API No. 30-025-08845), located at an unorthodox Jalmat infill gas well location 660 feet from the North line and 1980 feet from the East line (Unit B) of Section 9, are currently completed in the South Eunice-Seven Rivers-Queen Pool at standard oil well locations; however, all three are to be plugged back and recompleted up-hole into the Jalmat Gas Pool. This unit is currently simultaneously dedicated to the applicant's State "A" A/C-2 Wells No. 1, 29, 38, 40, 57, 63, 67, and 72.

ASE 12304: (Readvertised)

Application of Raptor Resources, Inc. for three unorthodox infill gas well locations, Lea County, New Mexico. Applicant seeks exceptions to the well location requirements provided within the "*Special Rules and Regulations for the Jalmat Gas Pool*", as promulgated by Division Order No. R-8170, as amended, for three unorthodox infill gas well locations within an existing standard 640-acre gas spacing and proration unit for the Jalmat Gas Pool comprising all of Section 8, Township 22 South, Range 36 East, which is located approximately 4 miles southwest of the Eunice airport (E04). This 640-acre unit was the subject of Division Order No. R-9073, dated December 14, 1989 [paragraph No. (3) of Exhibit A]. The three existing: (i) State "A" A/C-2 Well No. 24 (API No. 30-025-08833), located at an unorthodox Jalmat infill gas well location 1980 feet from the South line and 660 feet from the East line (Unit I) of Section 8; (ii) State "A" A/C-2 Well No. 25 (API No. 30-025-08834), located at an unorthodox Jalmat infill gas well location 660 feet from the North and East lines (Unit A) of Section 8; and (iii) State "A" A/C-2 Well No. 54 (API No. 30-025-08841), located at an unorthodox Jalmat infill gas well location 660 feet from the South line and 1980 feet from the East line (Unit O) of Section 8, are currently completed in the South Eunice-Seven Rivers-Queen Pool at standard oil well locations; however, all three are to be plugged back and recompleted up-hole into the Jalmat Gas Pool. This unit is currently simultaneously dedicated to the applicant's State "A" A/C-2 Wells No. 3, 26, 43, and 70. **NOTE:** Both the State "A" A/C-2 Wells No. 24 and 25 were the subject of Division Administrative Order NSL-2816-C (SD) dated October 13, 1999.

NOW, on this 5th day of April, 2000, the Division Director, having considered the record and the recommendations of the Examiner,


FINDS THAT:
