
Describe Cause of Problem and Remedial Action Taken.*

On Thursday November 8, 2007 at 1130 hrs a leak was discovered coming from a 3" steel flowline on EVGSAU #0524-036. Amount spilled was 21 bbls of oil and 32 bbls of produced water. The spill was not contained and affected approximately 8,000 sq/ft of pasture. The leak was found by a COPC employee. Upon arrival the MSO discovered that the leak was coming from the 3" steel flowline due to external corrosion.

Describe Area Affected and Cleanup Action Taken.*

The spill was not contained and affected approximately 8,000 sq/ft of pasture. The MSO shut in the well and called a vacuum truck to pick up free liquids. 3 bbls of oil and 5 bbls of produced water were recovered. The spill site will be delineated and remediated in accordance with NMOCD guidelines.
