All four of the Ricky wells are completed in the Basin Fruitland Coal. The # 1 and # 2 wells are completed in the upper zones and the # 1R and # 2R wells are completed in the lower zones.


Oil Conservation Division orders numbered R-12201 and R-12201A allowed Applicant to produce all four Ricky wells within the standard 320 acre (W/2) Basin Fruitland Coal proration unit. Production of all four Ricky wells during the pendency of a matter brought before the Oil Conservation Division for Simultaneous Dedication is authorized in a March 08, 2007 letter from Mr. Fesmire to William F. Carr, the attorneys for Applicant.

All issues and matters set forth in the original application for Surface Commingling dated May 19, 2003 and its subsequent amendments remain unchanged.

The proration unit (W/2) for and ownership of the upper and lower zones in all of the Ricky wells are identical. No new lands, leases or owners are involved in this request to add wells to order CTB 537.
