



The above referenced case involves an unorthodox well location for the Kutz Deep Well No. 2 which was originally filed as an administrative application for the S/2 of said Section. Thereafter, Breck Operating Company objected to the location and the matter was docketed as Case No. 10021 on he Examiner's docket of July 25, 1990.


