







Gentlemen:

In accordance with Rule 104-F of the State of New Mexico Energy and Minerals Department, Oil Conservation Division Rules and Regulations, Bass Enterprises Production Co. does hereby officially notify you, an offsetting operator of the referenced section, that the Poker Lake Unit Well No. 74 is to be located 1,060' FSL and 1,980' FEL for a S/2 proration unit. Due to the existence of a road traversing Section 24, the well location must be closer than 330' to an interior quarter-quarter section line. As such, the Oil Conservation Division rules and regulations require that official notice of same be sent before administrative approval of an unorthodox location can be granted.

In the interest of time and because the well location has not been moved closer to an exterior proration unit boundary, we respectfully request that you sign this letter in the space provided below. In so doing you will waive all objections to the drilling at this well location. For your information, we are enclosing a plat showing the well location and an insert reflecting the topographical problems caused by the existence of the road.
