Dear Mr. Bohling:

Reference is made to your application dated June 6, 1991 for an unorthodox Jalmat gas well located in an existing non-standard 600.10-acre gas spacing and proration unit (GPU) for said Jalmat Gas Pool comprising Lots 1, 2 and 4, S/2 N/2 and S/2 of Section 4, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order No. R-5523, dated September 6, 1977 and had dedicated thereon the J.F. Janda (NCT-F) Well No. 13 located in Unit P of said Section 4.

By Division Administrative Order NSL-2999(SD), dated March 20, 1991, an additional well for said GPU, the J.F. Janda (NCT-F) Well No. 16 located at an unorthodox gas well location 1980 feet from the North line and 660 feet from the East line (Unit H) of said Section 4 was approved. Authorization was also given in said administrative order to simultaneously dedicate Jalmat gas production from the J.F. Janda (NCT-F) Well Nos. 13 and 16 to the subject GPU.

It is our understanding that the subject well in this application was recently recompleted from the South Eunice Pool.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described well located at an unorthodox gas well location is hereby approved.



Dear Mr. Black:

Reference is made your application dated October 19, 1992 to form a standard 640-acre, more or less, gas spacing and proration unit in the Jalmat Gas Pool to comprise all of Section 4, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico, by combining an existing 600-acre, more or less, non-standard gas spacing and proration unit previously approved by Division Order No. R-5523, dated September 6, 1977, and a 40.03-acre tract consisting of Lot 3 (NE/4 NW/4 equivalent) of said Section 4.

The J.F. Janda (NCT-F) Well Nos. 13, 14 and 16 are all currently dedicated to the existing 600-acre, more or less, gas spacing and proration unit. Further, all three of the said wells were approved as unorthodox pursuant to Division Order No. R-5523, Administrative Orders NSL-2999-A(SD) and NSL-2999(SD), respectively.

It is our understanding at this time that Chevron is planning to recomplete its J.F. Janda (NCT-F) Well No. 8 in the Jalmat Gas Pool. Presently, the No. 8 well located 660 feet from the North line and 1980 feet from the West line (Unit C) is producing from the Eunice Monument Pool and Jalmat Oil Pool in which is currently dedicated the 40.03-acre tract.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, the unorthodox gas well location for the J.F. Janda (NCT-F) Well No. 8 is hereby approved.

Also, you are hereby authorized to simultaneously dedicate Jalmat gas production from the J.F. Janda (NCT-F) Well Nos. 13, 14 and 16 with the J.F. Janda (NCT-F) Well No. 8. Furthermore, you are hereby permitted to produce the allowable assigned to the subject GPU from all of the said wells in any proportion.


