Chevron U.S.A., Inc. respectfully requests your approval of this administrative application for the subject Unorthodox Gas Well Location and Simultaneous Dedication.

Chevron has just recently re-completed it's **J. F. Janda (NCT-F) Well No. 14** in the Jalmat Tansil Yates Seven-Rivers Queen (Pro Gas) Pool. It is our desire to simultaneously dedicate the existing 600-acre Jalmat Gas Proration Unit assigned to our J. F. Janda (NCT-F) Well Nos. 13 and 16 (Order R-5523 & Order NSL-2999(SD) to all three wells. As a result, the location of the J. F. Janda (NCT-F) Well No. 14 is unorthodox in that it is less than 990' from the outer boundary of the proration unit. The location of Well No. 14 is 660 feet FNL and 660 feet FEL, Unit Letter A, Section 4, Township 22 South, Range 36 East, Lea County, New Mexico.

In order to prevent waste, Chevron respectfully requests your approval of this administrative application for an unorthodox gas well location and simultaneous dedication under the provisions of Rule 104 (F). 





This cause came on for hearing at 9 a.m. on August 31, 1977,

NOW, on this 6th day of September, 1977, the Commission,  
a quorum being present, having considered the testimony, the  
record, and the recommendations of the Examiner, and being fully  
advised in the premises,

FINDS:

(1) That due public notice having been given as required  
by law, the Commission has jurisdiction of this cause and the  
subject matter thereof.

7 (2) That the applicant, Gulf Energy and Minerals Company,  
seeks approval of a 600-acre non-standard gas proration unit  
comprising all of Section 4 except the NE/4 NW/4 thereof, Township  
22 South, Range 36 East, NMPM, to be dedicated to its J. F. Janda  
Wells No. 7, located in Unit K, and Nos. 12 and 13, at unorthodox  
locations in Units O and P, respectively, of said Section 4.

(3) That the entire non-standard proration unit may  
reasonably be presumed productive of gas from the Jalmat Gas Pool  
and that the entire non-standard gas proration unit can be  
efficiently and economically drained and developed by the  
aforesaid wells.

(4) That approval of the subject application will afford  
the applicant the opportunity to produce his just and equitable  
share of the gas in the Jalmat Gas Pool, will prevent the economic  
loss caused by the drilling of unnecessary wells, avoid the  
augmentation of risk arising from the drilling of an excessive  
number of wells, and will otherwise prevent waste and protect  
correlative rights.

(5) That Order No. R-4288, which previously approved the subject 600-acre non-standard proration unit for dedication to Wells Nos. 7 and 13 only, should be superseded.

IT IS THEREFORE ORDERED:

(1) That a 600-acre non-standard gas proration unit in the Jalmat Gas Pool comprising all of Section 4 except the NE/4 NW/4 thereof, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico, is hereby established and simultaneously dedicated to its J. F. Janda Wells No. 7 located in Unit K and Nos. 12 and 13, at unorthodox locations in Units O and P, respectively, of said Section 4.

(2) That Commission Order No. R-4288, dated April 17, 1972, is hereby superseded.

(3) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.


