Chevron U.S.A. Inc. respectfully requests NMOCD approval of this administrative application for an unorthodox gas well location and simultaneous dedication.

The W.A. Ramsay NCT-A #43 was temporarily abandoned in 1995 after having produced from the Lower Queen (Penrose) of the Eumont Oil Pool since completion in August 1958. With your approval, it is our intent to re-enter this well and complete Yates/Seven Rivers/Queen intervals of the Eumont Gas Pool from approximately 3050' to 3300'.

The subject well is located on an existing 640-acre Eumont gas proration unit as defined by Division Order R-4496, dated March 21, 1973; this order authorized the simultaneous dedication of wells #17 and #46 to the GPU. Subsequent Administrative Orders granted simultaneous dedication of wells #35, #37, #42, #29, #40, and #44 to the GPU. Upon completion the subject well would be simultaneously dedicated with the aforementioned gas wells.

Average daily production volume for the eight wells currently dedicated the GPU is approximately 700 MCFD. Details for the W.A. Ramsay NCT-A Gas Proration Unit are provided in the attached Lease Evaluation spreadsheet.





### ORDER OF THE COMMISSION

### BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on March 14, 1973, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this 21st day of March, 1973, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Gulf Oil Corporation, seeks authority to simultaneously dedicate a 640-acre standard gas proration unit, Eumont Gas Pool, to two wells, the W. A. Ramsay Well No. 17 at a standard location in Unit J, and W. A. Ramsay Well No. 46 at a non-standard location in Unit E, Section 27, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico.
- (3) That the applicant seeks to produce the allowable from said gas proration unit from either or both of said wells in any proportion.
- (4) That the applicant further seeks the approval of the non-standard location of said W. A. Ramsay Well No. 46 located 1980 feet from the North line and 660 feet from the West line of said Section 27, Eumont Gas Pool, Lea County, New Mexico.
- (5) That approval of the subject application for simultaneous dedication and non-standard location will afford the applicant the opportunity to produce its just and equitable share of the gas in the subject pool, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights.

### IT IS THEREFORE ORDERED:

- (1) That Gulf Oil Corporation, is hereby authorized to simultaneously dedicate a 640-acre standard gas proration unit, Eumont Gas Pool, to two wells, the W. A. Ramsay Well No. 17 at a standard location in Unit J, and W. A. Ramsay Well No. 46 at a non-standard location in Unit E, Section 27, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico.
- (2) That the allowable assigned to said proration unit plus the underage accrued from January through March, 1973, may be produced from either or both of said wells in any proportion.
- (3) That the non-standard location of the applicant's W. A. Ramsay Well No. 46 located 1980 feet from the North line and 660 feet from the West line of said Section 27 in said pool is hereby approved.
- (4) That the effective date of this order shall be April 1, 1973.
- (5) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
