


San Juan County, New Mexico

Amoco Production Company hereby requests administrative approval for an unorthodox well location for the Pollock Com E #1R well in the Basin Fruitland Coal Pool. Amoco plans to recompleate this well from the Gallup formation to the Basin Fruitland Coal and Aztec, Pictured Cliffs formations prior to downhole commingling the well. The Gallup part of the hole will be abandoned. This well is at an orthodox location for the Pictured Cliffs, however, the Basin Fruitland Coal Pool Rules require all Fruitland wells to be in the Northeast or Southwest quarter of the section. Because of the recompleation of this well from the Gallup formation, it will be in an unorthodox location in the Fruitland (SE/4). Attached is a copy of the C-102 for the Pictured Cliffs and the Fruitland Coal formations.

A copy of this application will be submitted to the offset operators by certified mail with a request that they furnish your Santa Fe office with a Waiver of Objection, and return one copy to this office. Attached are plats showing the location of the well and all wells drilled in the area.


